PRICING SCHEDULE

1. Pricing schedule

The aim of the tender to acquire technical support on various planning projects when required by the municipality. Bidders will be appointed based on rates plus an escalation of 10% annually.

Bidders must note that professional fees are inclusive of expertise, services and professional support deemed reasonably necessary to execute a project. Administrative fees are inclusive of printing, stationary, communication costs and any other related expenses that are reasonably deemed necessary to execute a projects. These fees will be calculated using an hourly rate or part thereof.

Travel costs are expenses for transportation and related expenses such as site visits deemed reasonably necessary to execute a project. Travel costs will be estimated per kilometre and in line with the terms of reference as per allocation.

It is compulsory for bidders to utilise the tables below for evaluation purposes. The quantities below are for evaluation purposes only and all works and fees will be determined as and when required.
