4. ELIGIBILITY AND EVALUATION CRITERIA

4.1 Umgeni Water will only consider submissions from tenderers who satisfy the following criteria:

- a) the Tenderer or any of its directors/shareholders is not listed on the Register of Tender Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector;
- b) the Tenderer has not:
 - i) abused the Employer's Supply Chain Management System; or
 - ii) failed to perform on any previous contract and has been given a written notice to this effect;
- c) the Tenderer has completed and signed the Declaration of Interest and there are no conflicts of interest which may impact on the Tenderer's ability to perform the contract in the best interests of the Purchaser or potentially compromise the tender process and persons in the employ of the state are permitted to submit tenders or participate in the contract.

4.2 EVALUATION METHOD:

- a) The tender will firstly be evaluated on eligibility. If found to be eligible, it will be further evaluated on: Price & Preference using the 80/20 Preference Point Scoring System in terms of PPPF

5. SCOPE OF WORK

Umgeni Water (UW) is requiring the services of a Contractor to repair and refurbish a RDL 300-620A Bare shaft pump.

This refurbishment work will cover the following but not limited items;

5.1 PUMP CASINGS INSPECTION

The pump is a Horizontal, axially split volute casing, with upper and lower casing. Horizontal and opposite suction and discharge nozzle, in the lower casing. The surfaces between the casings of the pump are properly machined and the sealing must be done with seal bandage of silicone (598 HB Loctite).

Inspect & check the channels for replaceable wear rings in the lower casing, if worn advise and determine proposal for resolution of findings, **caution**, these wear rings are critical for protection of pump casing against wear caused by impeller rotation, therefore this is critical work.

Inspect & check for flatness on both the lower and upper casings mating surfaces. Obtain a precision straight edge that will cover the length and width of the pump case parting flange and a set of feeler gauges, and the bore must be checked for size.

Examine the pump bearing housing for wear or damage. Information regarding the bearings is contained in the K.S.B O & M Manual - Overhaul - Bearings - Examination of bearings.

5.2 INSPECTION OF THE IMPELLER & WEARING PARTS

The pump Impeller is radial, double suction, with vanes of wide curvature, fixed on the shaft by means of two symmetric parts set (space sleeve, shaft protecting sleeve and shaft nut).

The rotating element must be protected from ingress of dirt and physical damage during the refurbishment work execution, and the cartridge must be removed to a clean work area for dismantling.

After dismantling, clean and inspect the parts and inspect for wear or damage. In particular, check the running surfaces of rings and bushings. Damaged or excessively worn parts should be discarded. Re-usable parts should be prepared for short-term storage by applying light machine oil to all machined surfaces.

- Inspect impeller for wear or damage. Inspect impeller for cavitation marks (pits) in the suction area, erosion of vanes and cracks in the shroud. Smooth minor irregularities with a fine file or emery paper, replace impellers, if necessary. If impeller shows wear a balance check should be performed before use.
- It is recommended that the impeller is individually balanced on a balancing machine and for dynamic balancing please consult K.S.B O & M Manual.
- The assembled rotor is not balanced as a unit, since the deflection of the rotor is different during balancing in air to the deflection under the influence of hydraulic axial and radial bearing forces in the close clearances within the pump.
- Impeller Sleeves

Examine the impeller spacer sleeves, shaft protecting sleeves & wearing rings and distance sleeves for wear or grooving.

The outside diameter of each sleeve should be measured and a comparison made with the inside diameter of the component through which the sleeve passes. The amount of clearance between the two can thus be checked to determine whether or not it is within acceptable limits.

Measure the diameter of the impeller wearing rings and distance sleeves; measurements should be taken at intervals around the circumference to check for uneven wear.

- Measure the diametric clearance between corresponding components.
Measure the clearance between corresponding sets of rotating and stationary parts. Use several measurement locations, and then calculate the clearance as per OEM description for the pump.

5.3 PUMP SHAFT INSPECTION

Pump shaft is supported between bearings. Bearing casings are fixed to their brackets to facilitate the disassembly of rotor together with the bearing. The 300-620 A pump has bearing casing part integrated to the lower casing.

The 300-620 A pump has ball bearings in both sides.

The 300-620 A pump has shaft sealed by gland packing (standard) or optionally by mechanical seal. In the sealing area, the shaft is provided with easily replaceable protective sleeves.

The lantern ring, disposed between packing rings receives the liquid from the region of pump high pressure. Lantern ring makes the distribution of liquid, which lubricates the packing and avoid the entrance of air in the pump as well as liquid flow to the lantern ring is controlled by a valve installed in the pump external piping.

NOTE: Furthermore, it is the duty and responsibility of the Contractor to consult the K.S.B O & M Manual and verify the Shaft seal housing clearances, sealing clearances in the diameter $d_2 - d_1$, as well as the bearing clearances.

Examine the shaft keys and key ways. Renew damaged or worn keys.

- During any pump refurbishment, the clearance should be verified. Should dimensional verification indicate any existing deviation, please contact the OEM for the acceptable running clearance.

- Shaft Seal Housing clearances

$\varnothing D = 150\text{mm}$

$\varnothing d = 110\text{mm}$

$L = 150\text{mm}$

- Sealing clearances in the diameter $d_2 - d_1$ (See Figure.1) = 1.1 mm

- Bearing clearances

Drive End = 6316

Non- Drive End = 6316

NOTE: Inspection, verification and maintenance of wear areas, that means, clearances between impeller and casing wear ring or between this and the impeller wear ring should be made after reaching sealing clearance values mentioned on Table 1.(Please refer to section 1.1.3 above for clearances)

5.4 PUMP SPARES & MATERIALS

The Contractor is responsible for the supply and delivery of all the spares and accessories for this refurbishment work implementation.

The contractor shall record all spares/part that have been installed on the pump during refurbishment. Within the report expected from the contractor a list of spares should be in a table with the following specifications:

- Spare serial number
- Dimensions
- Material
- Manufacturer

5.5 TECHNICAL SPECIFICATIONS

5.6 WORK INSTRUCTION

5.6.1 As per scope of work and technical specification in sections 1 & 3 above.

5.6.2 The contractor shall collect & deliver the pump from Umgeni Water's Mill Falls Pump Station with the use of a suitable truck.

5.6.3 The contractor shall overhaul the pump, repair the parts that can be reutilised like casing, shaft, impeller and replace all of the parts that are damage.

5.6.4 The contractor to take two Umgeni Water employees to observe the refurbishment of the pump for the purpose of skills transferring.

5.6.5 Upon completion of refurbishment, the contractor shall do a performance test on the pump on a test bench.

5.6.6 The pump shall be delivered to Millfalls pump station in a wood box covered with plastic.

5.8 SHEQ

5.8.1 Security

5.8.1.1 The Contractor shall ensure that all tools and materials are kept under lock and key.

5.8.1.2 Umgeni Water is not responsible for the loss of the Contractor's equipment as a result of any cause whatsoever.

5.8.1.3 Umgeni Water reserves the right for security guards to search persons or vehicles entering or leaving the premises.

5.8.2 Permits

5.8.2.1 The Contractor shall not perform work for which the issuing of a permit is required prior to the obtaining of a duly completed and approved permit. The following are included as hazardous tasks and may not be carried out by the Contractor unless a work permit has been duly authorized by Umgeni Water:

- Cutting or welding in any risk area.
- Working at a height of more than two meters.
- Working with hazardous substances (e.g. toxic chemicals and flammable liquids).
- Working inside confined spaces (e.g. vessels, chambers and pipelines).
- Working in electrical lockouts installations.
- Breaking in any live water main.

5.8.3 Housekeeping

- 5.8.3.1 After the completion of work the Contractor must make good and clean up the site area where work was performed, and also at the completion of the contract.
- 5.8.3.2 Sites must be kept reasonable tidy during work operations.

5.8.4 Alcohol or intoxicating Substances

The Contractor shall ensure that no alcohol or intoxicating substances are on their possession while on site. Anyone suspected to be intoxicated or under influence of Alcohol shall not be allowed on site.

5.8.5 Safety

- 5.8.5.1 Umgeni Water has a strict attitude when it comes to personal safety of all on site. The Contractor is expected to provide a Health and Safety File to meet the minimum requirements of the Construction Regulations 2014.

6.5.2 The Health & Safety file must be submitted to the SHEQ co-ordinator prior to any work execution. The Contractor and sub-contractors have to attend a Compulsory Induction before starting the project.

- 5.8.5.2 Unsafe activities, equipment and procedures shall not be tolerated. It should be noted that if this work requires people to work in elevated positions and confined areas, compliance to the OHS Act is mandatory. The Contractor will be required to submit together with the quotation a schedule of all his activities and as to how he intends to carry them, to the Umgeni Water Project Manager and Safety Officer for approval.

5.8.7 Safety Induction

The qualifying contractor to make sure that all staff who will be working on this Project must be Safety Inducted before the commencement of any work. This will include all sub- contractors' staff.

5.8.8 Safety Clothing and Equipment

The Contractor shall supply all the Umgeni Water specified safety clothing and equipment for his workmen on site. The Contractor's workmen on site shall wear hard hats, safety glasses, safety shoes and overalls where applicable.

5.8.9 Accidents

- 5.8.9.1 In addition to any statutory obligations, the Contractor shall immediately report to the Project Manager every occurrence causing damage to property or injury to persons.
- 5.8.9.2 If required by the Employer, the Contractor shall submit a further report in writing to the Employer within 48 hours of such requirement setting out full details of the occurrence.
- 5.8.9.3 The Contractor shall report those injuries that are reportable in terms of Section 24 of the OHS Act (1993) to the Department of Labour.
- 5.8.9.4 The Employer shall have the right to make any queries either on the Site or elsewhere as to the cause and results of any such occurrence and the Contractor shall make available to the Employer the necessary facilities for carrying out such enquiries.

5.9 SITE INFORMATION

- 5.9.1 Midmar's Mill Falls pump station is situated in Howick, which is approximately 25 Km from the Pietermaritzburg City Centre and the site is approximately 3 Km from the Howick City Centre; Coordinates {UW Head Office – Mills Falls Pump Station Lat: -29.499686 Long: 30.217777}

5.10 GENERAL

- 5.10.1 Various standard and project specifications refer to equipment being equivalent to a certain brand article. This should be read as equipment that would normally meet the requirements of the Umgeni Water Maintenance Engineer, but as brand articles are always subject to changes by the manufacturers, it remains the Tenderer's responsibility to ensure that such brand article will also meet the performance and other technical requirements of the equipment to be serviced.
- 5.10.2 Such requirements shall be read as being in addition to that which the brand article can provide. If the brand article cannot be offered by the Supplier, to meet such requirements, then the Tenderer must allow for the adjustment of the brand article to comply with such requirements.
- 5.10.3 In preparing the installation and fitting work, the Umgeni Water Maintenance Engineer will have contact with Suppliers of equipment, to allow for such normal requirements with regard to equipment size, access for installation, access for maintenance, mass, electrical supply, safety precautions, etc., that Suppliers might have, in order to ensure proper installation and future safety and optimum operation of such equipment.
- 5.10.4 As the final selection of spares / equipment is, however, in the hands of the successful Tenderer, and the contract for the supply of the spares / equipment, is between the Contractor and the Supplier, it shall be the Contractor's responsibility to ensure that the spares / equipment ordered will be suitable for the Alfa Laval Centrifuge machines in which it will be installed and that other influences shall not interfere with the safe, and optimum future operation of the equipment.
- 5.10.5 Particular attention must be given to the aspects of easy accessibility for maintenance and adjustment and specific safety requirements of particular suppliers.
- 5.10.6 Preference will be given to spares / equipment and materials of local manufacture where such equipment and materials meet with the requirements of the standard and project specifications.
- 5.10.7 Tenderers shall only offer spares / equipment and materials of a well-known recognised make, unless prior approval has been obtained from the Umgeni Water Maintenance Engineer.
