



1. INTRODUCTION

This document establishes the Technical Evaluation criteria for the cleaning of office and ablution facilities for Outside Plant at Kriel Power Station.

2. SUPPORTING CLAUSES

2.1 SCOPE

The scope will cover all the office and ablution facilities for outside plant.

2.1.1 Purpose

The purpose of the tender technical evaluation strategy is to define the Mandatory Evaluation Criteria for the tenderer to demonstrate that they will be able to manage the service and the responsibilities performing the work.

2. TECHNICAL EVALUATION THRESHOLD

The minimum weighted final score (threshold) required for a tender to be considered is **80%**.
