### 3. Evaluation Methodology

The attendees were taken through the stages of Evaluations as follows:

- **3.1** Stage 1 step 1: Administrative responsive test
  - Timely submission via Portal
  - Verification of the validity of the returnable documents
- **3.2** Stage 1 step 2: Substantive responsive test
  - Whether the tender contains a price offer.
  - whether any technical pre-qualification criteria set by Transnet, have been met as follows:
  - Valid registration of key personnel as follows:
  - Professional Land Surveyor to be registered with South African Geomatics Council (SAGC) as PrLS.
  - Candidate Civil Engineer to be registered as a Candidate Engineer with Engineering Council of South African (ECSA)
  - Utility Detection Technician Certified by Original Equipment Manufacturer (OEM).

It was emphasised that any tenderer that fails to meet the stipulated Eligibility criteria will be regarded as an unacceptable tender.

- The tenderers were taken through the functionality evaluation for the following elements:
- T2.2-02 Programme
- T2.2-03 Experience of Key Personnel
- T2.2-04 Tenderers Previous Experience
- T2.2-05 Method Statement

Only those tenderers who obtain the minimum number of evaluation points for Functionality will be evaluation further in term of Price and Applicable Preference Point System. The minimum qualifying score for functionality is **60 points** 

#### **3.4** Stage 3 Preference Point System

- 80/20 (or 90/10 if project exceeds R50m).
- Points for price and specific goals:
  - ✓ B-BBEE Status Level of Contributor 1 or 2 (Certificate or Affidavit)
  - √ 30% Black Women Owned Entities (Certificate or Affidavit)
  - ✓ EME or QSE 51% Black Owned (Certificate or Affidavit)
