Lynnfield is a wastewater works that is located within Lynnfield park it has a storm water dam that is not lined as a results it is subjected to soil erosion which poses a danger to the adjacent concrete structures which will lead to a catastrophic incident and plant unavailability.

2. Description of goods/ services required

The service provider will be required to line the side walls of the dam with bidim A4 (6mx150m)
Bidim will be field with G5 commercial material.

Bottom half of the dam wall will be lined using Multicell 100mm (5m x 10m)

Service provided must supply excavator for the preparation of the storm water dam side walls prior to the installation of bidim and multicell

3. Deliverables/Key Outcomes.

The service provider will be required to line the side walls of the dam with bidim A4 (6mx150m)
Bidim will be field with G5 commercial material.

Bottom half of the dam wall will be lined using Multicell 100mm (5m x 10m)

Service provided must supply excavator for the preparation of the storm water dam side walls prior to the installation of bidim and multicell
