SCOPE OF WORK:

1. SCOPE OF WORK AND / OR SPECIFICATION

SCOPE OF WORK

Johannesburg Water regularly advertises tenders, vacancies and other general notices in local newspapers to provide opportunities to interested service providers and job seekers as well as keeping the public informed on other general matters of interest. Advertisements will be placed mainly in the Star, Citizen, Sowetan, The Sunday Times, Beeld / Rapport, Mail and Guardian and City Press as these newspapers cater for our target market, i.e. both black and white owned businesses, students, job seekers and the general public and these are also widely read and circulated. However, other newspapers have also been included in instances when a need arises to utilize their services.

Johannesburg Water through this Tender, seeks responses from interested parties to perform the following:

- a) Receive draft advertisements from JW electronically.
- b) Design and format the advertisement to an acceptable standard and in the required space and size.
- c) Proofread all advertisements.
- d) Liaise with the responsive JW official to ensure accuracy.
- e) Liaise with newspaper houses.
- f) Ensure advertisements are placed in the appropriate section of the newspapers to ensure maximum exposure to interested parties.
- g) Ensure that the advertisement appears in the newspapers as requested and, on the date, required.
- h) Make provision for urgent ad hoc placements with newspapers in exceptional cases.
- i) Maintain a good relationship with newspaper houses.
- j) Ensure a quick turnaround time.
- k) Ensure that advertisements always comply with Johannesburg Water requirements and in the format approved.
- l) Ensure that adequate credit facilities or support from newspaper houses are in order at all times.

2. THE NEWSPAPERS THAT JOHANNESBURG WATER PLACES THEIR ADVERTS:

3. RESPONSIBILITY OF SERVICE PROVIDER:

- a) Maintain credit facilities with newspapers houses or have a letter of support from the newspaper house and maintain a healthy working relationship with the newspaper houses for the Tender duration.
- b) Maintain a good working relationship with Johannesburg Water.
- c) Upon receiving notice from Johannesburg Water, liaise with the above newspapers to inform them that they will be confirming adverts later on and that the newspaper should reserve space.
- d) Receive draft advertisements, proofread the advert and communicate electronically to Johannesburg Water of any changes that need to be done. This must be done within two (2) hours of receiving the draft advert.

- e) Prepare a quotation for adverts that will be placed and send them to the Johannesburg Water representative.
- f) Follow up on the approval of the quotation if the authorization has not been received.
- g) Place the adverts with the newspaper houses determined by Johannesburg Water before the cut off time.
- h) Confirm if you managed to secure a spot on the above newspaper by sending tear sheets to Johannesburg water within twenty-four (24) hours.
- i) Submit digital proof, such as a PDF tear sheet, of placement of advert within twenty-four (24) hours of placing the advert.
- j) Ensure placement in the correct section as per request and take corrective action at own cost if misplaced.
- k) Complete and submit the statement and invoice to Johannesburg Water finance department before the end of the month for payment to be made as per agreed payment terms.

RESPONSIBILITY OF JOHANNESBURG:

- a) Maintain a good working relationship with Johannesburg Water.
- b) Electronically liaise with the service provider before 10 am so that the service provider can inform the new newspaper houses above requesting space confirmation for an advert the following day.
- c) Send a draft advert to the Service Provider.
- d) Urgently attend to any issues picked up by the Service Provider and resend the advert.
- e) Sign off the final advert and submit electronically to the Service Provider before the agreed submission time to ensure that all the adverts will be placed on the determine newspaper houses for the advert.
- f) Pay Service Provider as per term provided Service Provider has submitted accurate and complete invoices and statements to finance before the due date and time.

DURATION OF THE PURCHASE ORDER:

The contract duration will be for a maximum amount of R750 000.00 or a period of six (06) months on a month-to-month basis.

AWARD STRATEGY:

Evaluation in terms of Price and Preference will be per item and award will be made to the highest scoring tenderer per item. In this instance award may be to one or more tenderers.

Total funding requirements will be based on the overall total estimated cost for the three years contract term.

Stage 1: Mandatory Evaluation

1. The tenderer is required to submit proof that they have Credit facilities or letter of support from the newspaper house for the newspaper adverts the tenderer is tendering for. For example, if the tenderer is tendering to advertise tender adverts on the Citizen, the tenderer must submit the required proof that they have credit facility or letter of support from or with the newspaper house.
