1. BACKGROUND

The National Heritage Council (NHC) of South Africa is a public entity that is responsible for the preservation of the country's heritage. The important areas that the NHC focusses on are policy development for the sector to meet its transformation goals, public awareness and education, knowledge production in heritage subjects that were previously neglected, as well as making funding available to projects that place heritage as a socio-economic resource.

The NHC is a Schedule 3A public entity in terms of the Public Finance Management Act 1 of 1999 as amended by Act 29 of 1999, that came into existence through an amendment of the Cultural Laws Second Amendment Act, Act 69 of 2001, and was officially constituted through the National Heritage Council Act, Act 11 of 1999).

The NHC requires the service of a suitably qualified and experienced panel of legal service providers to carry out the legal functions of the NHC and enter into a service level agreement for the period of thirty-six (36) months.

The NHC does not guarantee exclusive procurement from the Legal Services company, nor any minimum order or quantity of services. The Legal Services company is expected to win over market share through the quality of services rendered and competitive prices.

2. PURPOSE

- 2.1. The National Heritage Council would like to invite suitable, qualified and competent Legal Practitioners to send proposals to be considered for inclusion on its panel of 5 Legal Practitioners, as 'preferred service providers'. Preferred service providers imply that the selected firms will form a pool of legal practitioners who would not necessarily be the contracted service provider but will be requested to quote before their services are utilized.
- 2.2. The panel of Legal Practitioners will be required to render legal services within various Legal Disciplines indicated in the scope of services to NHC, on an ad hoc basis, for a period of three (3) years.
- 2.3. The NHC is under no obligation to obtain legal services during the period of contract from all the listed service providers.

3. TERMS AND CONDITIONS

- 3.1. This Request for Proposal (RFP), as compiled by NHC is being made available, on the same basis to all bidders and a bidder submitting a response thereto will be deemed to do so on the basis that they acknowledge and accept the terms and conditions set by NHC.
- 3.2. The successful bidder shall upon receipt of written notification of an award, be required to sign a Service Level Agreement for a period of 36 months which will form an integral part of the General Conditions of Contract. This SLA will serve as a tool to measure, monitor and assess the supplier's performance and ensures effective delivery of

service, quality and value-add to NHC. The scope of work shall form part of the agreement.

4. CONFIDENTIALITY

- 4.1. The Legal Practitioners will be required to sign confidentiality and/or indemnity agreements with NHC.
- 4.2. The bidder undertakes, at any time during the term of its appointment and after any termination or cancellation thereof, not to directly or indirectly disclose, or directly or indirectly use, whether for its own benefit or that of any other person any confidential information of NHC including that of or any information relating to its clients, customers, suppliers, donors, sponsors or agents.

5. INTELLECTUAL PROPERTY RIGHTS

- 5.1. All copyright and intellectual property rights that may result as consequences of the work to be performed will become the property of NHC.
- 5.2. Legal Practitioners must hand over all documents and information in any format, including copies thereof, that it received from NHC or that it had access to during the assignment immediately after completion of the assignments to NHC.
- 5.3. Legal Practitioners shall deliver to NHC, on completion of an assignment, any security devices, passwords or protective mechanisms to the soft versions of documents that were written and NHC will have the right to amend and change these without obligation whatsoever to the firms of attorneys upon completion of the assignment.
- 5.4. A due diligence review may be conducted at the sole discretion of NHC at any time prior to the awarding of the contract which may include but is not limited to conducting site visits at bidder's corporate offices.
- 5.5. Only legal practices established and registered in accordance with the provisions of the Legal Practice Act, 2014 (Act No. 28 of 2014 as amended) will be considered for this tender.
- 5.6. NHC does not guarantee that bidders will receive instructions in the event that they are appointed onto the NHC panel of Legal Practitioners.
- 5.7. All instructions to selected practitioners on the panel of Legal Practitioners shall be given in writing, by a duly authorized representative of NHC.
- 5.8. NHC promotes local production and content and for purposes of this RFP, NHC reserves the right to only consider South African Based Legal Practices for appointment under this RFP.
- 5.9. NHC reserves the right to interview panel members that would have been shortlisted for specific assignments.
- 5.10. NHC may, at its sole discretion award an assignment or any part thereof to more than

one panel member or to any legal firm not forming part of the panel of attorneys depending on the nature of the assignment.

- 5.11. Legal Practitioners may not cede or assign any part of their agreement with NHC nor subcontract any part of the work assigned to them without the prior written authorization of NHC.
- 5.12. Failure to comply with any conditions of this request for a proposal will invalidate respective tender proposal.
- 5.13. Regular monthly written feedback must be given to the Company Secretary and Chief Legal Counsel, or his/her nominee on all matters, including employment law matters, received from the NHC with the service provider, at no costs to the NHC.
- 5.14. When cases have been postponed at the request of the service provider acting on behalf of NHC owing to non-compliance with any procedural requirements, the service provider who was negligent in this regard will bear the costs of postponement, and this amount will not be recovered from NHC.
- 5.15. Successful bidders will be required to negotiate fees with advocates and inform NHC in writing before a brief is finalised. Service providers may not appoint Senior Counsel, unless written instructions to this effect have been received from NHC.
- 5.16. Payment of legal fees by NHC will be affected within 30 (thirty) days from the date of receipt of an acceptable invoice.
- 5.17. If any conflict of interest is discovered during a particular assignment, NHC reserves the right to summarily cancel the services agreement and demand that all information, documents and property of NHC be returned forthwith.
- 5.18. Where the panel falls short of other fundamental legal aspects, NHC reserves the right to appoint Legal Practitioners outside the appointed panel.
- 5.19. NHC shall be entitled, in its discretion, to remove a Legal Practitioner from the panel before the expiry of the three (3) years' period by written notice and recall all the files in the possession of the said firm of attorneys.
- 5.20. No entity may be involved, whether directly or indirectly, in more than one Bid in response to the RFP.

A failure to comply with this requirement may, within the sole discretion of NHC, result in disqualification of the relevant entity.

6. SCOPE OF WORK

The preferred service providers will be expected to render services on an ad hoc basis to NHC in the following service categories aligned to the core functions of Contract Administration and Legal Advisory Directorates within Legal Services:

Bidders must indicate in their proposals the relevant experience and exposure in relation to the selected service categories.

6.3 NHC intends to promote broad-based transformation and development of small and medium firms in this industry and as such will appoint Legal Practitioners in the following categories. The bidder must indicate the category relevant to it:

7. FIRM CATEGORY

7.1 DEFINITION

Category 1: Small Firms

Firms with an annual turnover of not more than R10 million

Category 2: Medium Firms

Firms with an annual turnover greater than R10 million
but less than R50 million

Category 3: Large Firms

Firms with an annual turnover greater than R50 million

Note: Bidders must submit their latest financial statements as proof of their annual turnover as confirmed by an independent Accountant. Small businesses with no financial history must submit a letter from their independent accounting firm confirming their financial status and/or projections.

7.2 It is NHC's objective to promote the participation of historically disadvantaged professionals through its panel of Legal Practitioners. Bidders are requested to indicate in their proposals how they will assist NHC in achieving this objective.

7.3 It is understood that the legal fees are based on hourly rates and that budgets are

compiled once the appointed law firm has assessed the likely extent of the work and is subject to approval by management.

- 7.4 Financial proposals will be compared on the total estimated legal fees for the period of three years. However, legal firms are also required to submit a table of hourly rates as per the table below. Rates should be inclusive of overheads and VAT. If a particular category does not exist for the firm, it can be omitted.

NB: Travel rate per km in case of any travel that may take place during the appointment period must be included.

We will pay the rate per km as per the tariffs published by Department of Transport up to 1600 sedan. Log sheets will be required when submitting the invoice.

A breakdown of disbursements e.g. Copy charges, telephone calls, etc. must also be included. Proof will be required with each payment.

9. HANDOVER REPORTS AND SKILLS TRANSFER

The successful preferred suppliers will be required to ensure handover and transfer of skills to in-house legal advisors of NHC as and when they are issued with instructions/assignments by NHC.

10. EVALUATION PHASES

The evaluation of the bids will be conducted in line with the Preferential Procurement Regulations of 2022 as issued in terms of section 5 of the Preferential Procurement Policy Framework Act number 5 of 2000 (PPPFA) as follows:

- 10.1 Mandatory Compliance and compliance with the requirements stipulated in the Terms of Reference
- 10.2 Functionality Evaluation Criterion
- 10.3 Price and Specific Goals

11. MANDATORY REQUIREMENTS

11.1 Bidders will be evaluated according to compulsory and pre-qualification requirements which include submission of mandatory information and/or documentation. Bidders that fail to meet the pre-qualification requirements of the request will not be considered further for evaluation on technical requirements as per Phase 2.

11.2 Bidders are required to complete the table. Should the space be inadequate, bidders are required to copy the table and provide the information as an annexure and refer in this table to the specific page. Failure to complete the table may result that the proposal be regarded as a non-responsive bid.

12. ACCREDITED PROFESSIONAL MEMBERSHIP

- 12.1. It is Compulsory for the senior resources of the preferred service provider (i.e. directors, senior manager and specialists) to have the appropriate professional qualifications(s) enabling them to perform legal services. The minimum required membership to be considered is admission as Legal Practitioners in terms of Legal Practise Act 28 of 2014 with a valid Fidelity Fund Insurance.

Compulsory documentation that must be submitted with the bid proposal. Non-submission of the documents will result in disqualification.

The minimum qualification score for functionality / technical evaluation is 70%. All bids that fail to achieve the minimum qualification score on functionality shall not be considered for further evaluation on Price and strategic goals.

All quotations will be evaluated based on compliance with compulsory requirements, compliance with specifications / Terms of Reference and the 80/20 preference point system prescribed by the Preferential Procurement Policy Framework Act 5 of 2000 and its Regulations. 14.2. The estimated hours must be indicated and the applicable cost.

14.3. The NHC will only pay for actual hours worked. Timesheets and supporting documentation must be submitted.

15. SERVICE LEVEL AGREEMENT

The successful service provider/s will be required to sign a service level agreement for the duration of the contract. No service may be rendered unless an official purchase order was issued and/or the Service Legal Agreement has been signed.

16. BID SUBMISSION

The completed bid submissions reflecting the bid number and the name of the bidder must be submitted on the eTender portal at www.etenders.gov.za or via email to tenders@nhc.org.za. The email address is an unattended email used for the submission of bid proposals only. No other submissions will be accepted.

Emailed bid proposals must include in the subject line, the bid number and the bid name / project name applicable to this bid document. The name of the bidder must appear in the email address as well as the contact information. NHC reserves the right to communicate with the bidder via email if the attached document(s) cannot be opened.

Enquiries must be directed via email to s.skenjana@nhc.org.za, cc procurement@nhc.org.za with the heading that includes the bid number and bid name in the subject line as well as the bidder name in the email.

Bid proposals must be submitted on the eTender portal or via email as stated above not later than the following date and time:

17. LATE SUBMISSION

Bid documents submitted after the closing time and date, will not be considered. **No submissions sent by hand or facsimile will be accepted.** Bid proposals must reach the NHC via eTender or email by no later than the indicated date and time.

Late bid proposals will not be accepted.

18. LEGISLATIVE FRAMEWORK OF THE BID

The following legislation, but not limited to, the following must be adhered to:

- 18.1 The Constitution of the Republic of South Africa;
- 18.2 Public Finance Management Act, 1999 (Act no 1 of 1999) as amended by Act 29 of 1999 (PFMA);
- 18.3 The Treasury Regulations (TR) issued in terms of the PFMA;
- 18.4 The South African Legal Practice Act, Act 28 of 2014;

19. COMPLIANCE WITH GENERAL CONDITIONS OF CONTRACT

No alteration, variation or amendment of the Contract (of which this bid represents the offer) shall be permitted unless otherwise agreed to in writing. Should the prospective bidder, in the case of non-compliance, wish to make any amendments to the conditions stipulated by the NHC in this bid, which shall form the offer element of a Contract and if it is accepted by the NHC, then such proposed amendments shall be clearly stipulated by the prospective bidder and where possible, stating the increase or decrease in the cost involved by such proposals. The NHC reserves the right to reject such submissions.

Misrepresentation of facts will result in disqualification and cancellation of the Contract.

20. NATIONAL HERITAGE COUCL LIABILITY

The NHC does not bind itself to accept the lowest or any bid proposal, nor to assign any reason for the rejection of a bid proposal, nor shall it be responsible for or pay expenses or losses that may be incurred by the prospective bidder in the preparation and delivery of its submission.

21. SUBMISSION ACCEPTANCE

No submission shall be deemed to have been accepted, unless and until a formal appointment letter is issued to the successful bidders. Submissions shall remain open for acceptance by the NHC for a period of 90 (ninety) days from the date on which they are returnable in terms of this bid.

22. TERMS OF ENGAGEMENT

- 22.1 The successful bidder shall not take more than one (1) month to deliver from date of bid award unless otherwise indicated and agreed between the bidder and the NHC.
- 22.2 The bidder shall be available for consultation with the NHC representative.
- 22.3 The Bidder shall manage confidential all data, information and insights gained in execution of work for the NHC.
- 22.4 NHC retains the right to negotiate with the successful bidder for partial execution of the proposal.
- 22.5 NHC retains the right to enter into a non-exclusive agreement with bidders that do not restrict the procurement of goods and services from other service providers.
- 22.6 NHC retains the right to require the bidder to obtain permission in writing from the NHC prior to replacement of individuals proposed for execution of the bid.
- 22.7 The proposals presented are to be as comprehensive as possible and NHC reserves the right to request the Bidder to provide more details.
- 22.8 Bidders shall adhere to the conditions stipulated in the General Conditions of Contract as prescribed by the National Treasury.
- 22.9 Bidders must ensure that the complete bid document is submitted with all additional required information and any other documents that the bidder wishes to supply to substantiate or clarify specific aspects in the proposal.

23. CONTENTS OF THE SUBMISSION

The bid proposal must be structured in accordance with the requirements stipulated in this bid document, following the guideline as set below:

- 23.1 Company information, track record and relevant documentation. The bid proposal must include all relevant information about the bidder, which is thought appropriate to assist the NHC to assess its capabilities, capacity, outputs, value adding abilities, competitive advantage, etc.
- 23.2 Expertise and capacity of the bidder
- 23.3 Accredited professional membership
- 23.4 Quality control
- 23.5 Resource planning
- 23.6 Core management team proposed
- 23.7 The breakdown of the complete terms of reference with associated cost.
- 23.8 All Standard Bidding Documents (SBD) completed and signed.

24. AMPLIFICATION OF SUBMISSIONS

The NHC may, after the opening of submissions, call on the prospective bidder to amplify in writing any matter which is not clear in the prospective bidder's submission and such amplification shall form part of the original submission. In the event of the prospective bidder failing to supply such information, the submission will be liable to rejection.

25. COST OF PROPOSAL

THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

INTRODUCTION

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works or services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

1. PILLARS OF THE PROGRAMME

- 1.1. The NIP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$ 10 million or other currency equivalent to US\$ 10 million will have a NIP obligation. The threshold of US\$ 10 million can be reached as follows:
 - (a) Any single contract with imported content exceeding US\$ 10 million.
or
 - (b) Multiple contracts for the same goods, works or services each with imported content exceeding US\$ 3 million awarded to one seller over a 2-year period which in total exceeds US\$ 10 million.
or
 - (c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US\$ 10 million.
or
 - (d) Multiple suppliers of the goods, works or services under the same contract, where the value of the imported content of each allocation is equal to or exceeds US\$ 3 million worth of goods, works or services to be the same government institution, which in total over two (2) year period exceeds US\$ 10 million.
- 1.2. The NIP obligation applicable to suppliers in respect of sub-paragraphs 1.1 (a) to 1.1 (c) above will amount to 30% of the imported content whilst suppliers in respect of paragraph 1.1 (d) shall incur 30% of the total NIP obligation on a pro-rata basis.
- 1.3. To satisfy the NIP obligation, the DTI would negotiate and conclude agreements such as investments, joint ventures, sub-contracting, licensee production, export promotion, sourcing arrangements and research and development (R&D) with partners or suppliers.
- 1.4. A period of seven years has been identified at the time frame within which to discharge the obligation.

2. REQUIREMENTS OF THE DEPARTMENT OF TRADE AND INDUSTRY

- 2.1 In order to ensure effective implementation of the programme, successful bidders (contractors) are required to, immediately after the award of a contract that is in excess of **R 10 million** (ten million Rands), submit details of such a contract to the DTI for reporting purposes.
- 2.2 The purpose for reporting details of contracts in excess of the amount of R 10 million (ten million Rands) is to cater for multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as provided for in paragraphs 1.1 (b) to 1.1 (d) above.

Prices	<p>17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.</p>
18.	Contract amendments	<p>18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.</p>
19.	Assignment	<p>19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.</p>
20.	Subcontracts	<p>20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.</p>
21.	Delays in the supplier's performance	<p>21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.</p>

		<p>21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.</p> <p>21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.</p> <p>21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.</p> <p>21.5. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.</p> <p>21.6. Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.</p>
22.	Penalties	<p>22.1. Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.</p>
23.	Termination for default	<p>23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:</p> <ul style="list-style-type: none"> a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2; b) if the Supplier fails to perform any other obligation(s) under the contract; or c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

		<p>23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.</p> <p>23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.</p> <p>23.4. If a purchaser intends imposing a restriction on a supplier of any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.</p> <p>23.5. Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.</p> <p>23.6. If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:</p> <ul style="list-style-type: none"> a) the name and address of the supplier and / or person restricted by the purchaser; b) the date of commencement of the restriction c) the period of restriction; and d) the reasons for the restriction. <p>23.7. If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.</p>
24.	Anti-dumping and countervailing duties and rights	<p>24.1. When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount</p>

		<p>of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.</p>

Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.</p> <p>25.2. If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.</p>
26.	Termination for insolvency	<p>26.1. The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.</p>
27.	Settlement of Disputes	<p>27.1. If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.</p> <p>27.2. If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.</p> <p>27.3. Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.</p> <p>27.4. Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.</p> <p>27.5. Notwithstanding any reference to mediation and/or court proceedings herein,</p> <ul style="list-style-type: none"> a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and b) the purchaser shall pay the supplier any monies due to the supplier.
28.	Limitation of liability	<p>28.1. Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6:</p> <ul style="list-style-type: none"> a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or

		<p>interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and</p> <p>b) liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.</p>
29.	Governing language	29.1. The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
30.	Applicable law	30.1. The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
31.	Notices	<p>31.1. Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.</p> <p>31.2. The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.</p>
32.	Taxes and duties	<p>32.1. A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.</p> <p>32.2. A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.</p> <p>32.3. No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.</p>
33.	National Industrial Participation (NIP) Programme	33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
34.	Prohibition of Restrictive practices	<p>34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).</p> <p>34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.</p> <p>34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the</p>
