5. SCOPE OF WORK

Purchase, Collect and Removal ~ 31 800L of transformer oil at Acacia Power Station. The oil contains PCB content of 2 ppm, is both transportable and reusable – this was confirmed by Eskom Oil specialist Andries Smit.

The purchaser must assure the site be left clean at completion of their collection and removal of the oil.

The scope of work will include the purchase, collect and removal of transformer oil at Acacia Power Station. Buyers must show their interest to participate by submitting all tender returnable specified on the tender enquiry. **The collection of the transformer oil cannot be stored in flow bins or any such storage, only a tanker may be used to collect and transport the oil. The successful tenderer must ensure that the correct fittings for drainage of the oil from the transformer to the tanker are used, to avoid unnecessary oil spillage.**

The purchaser will be responsible for the safe collection, handling, removal, and transportation of the scrap oil within 2 days of notification of successful tender.

It remains the responsibility of the buyer to be fully familiar with the condition of the scrap oil before tendering. Disputes regarding the condition of the items after tender closing will not be accepted or allowed.

The purchaser will be responsible for the safe collection, handling, removal, and transportation of the used transformer oil as well as to clean the site, qualified labour and suitable certified plant, machinery, equipment and transport for this purpose.

Payment shall be made to Eskom no later than **five days after the date of the sale based on the actual quantity in Litres**. The release of the scrap oil to the new buyer will take place immediately after notification of successful tender and the buyer acquiring a permit to remove and transport the scrap oil.

The goods on sale will be identified by Eskom.


