Technical specification for roof re-thatching at Grasdak

No	Description	Frequency (once off)	Unit price	Total Cost
1	Rethatching Grasdak 200 M2:			
1.1	Identify all rotted, decayed, loose thatching material on the entire thatching of the Grasdak.			
2	Clean and remove decayed parts caused by wind, rain, hails, etc. on the entire top surface of the roof.			
3	All rotted thatching material on the roof should be completely stripped out.			
4	The entire roof should then be dressed by brushing prior to the application of any new thatch layer.			
5	Rethatch and replace all rotted, decayed, loose part of the entire roof using the same natural and treated material against fungal attacks used on the existing roof.			
6	The stems of the grass should slope steeply and be tightly packed so that water runs from tip to tip over the surface rather than penetrate into the thatch.			
7	The thatch structure to be fire-resistance enhanced by the application of the fire retardants, which will retard the spread of flame for fire control measure.			
8	The thatch density should be at least 35 to 50 kg/m ² for a thickness of 175- 220 mm			
9	The area experiences heavy lightnings during the rainy season and therefore no wire must be used in the			
10	Thatch must be treated on both sides with an SABS approved fire retardants accompanied by an approved MSDS.			

11	Any treatment should be applied to both the interior and exterior to a depth of at least 65 to 75mm in order to improve the effectiveness of the thatch.			
12	Wooden poles, doors and windows must be treated with a coat of Carbolinium/ Creosote paint to protect them against weathering and insects.			
13	Provide an update Health and Safety file with a Covid-19 prevention plan.

2. SPECIAL CONDITION

- There will be a compulsory site inspection/ meeting. Failure to attend this meeting or inspection will lead to the bidder to be automatically disqualified.
- Three weeks period has been allocated for the FULL completion of this project (or as stipulated during site visit). This includes the snag list corrections and final sign of the project.
- The project plan must be provided indicating time lines with deliverables.
- Non- submission of completed similar projects would be deemed as non-compliance and the bid might be removed from the process.
- CIDB Construction Certificate from grade one (1) GB required.
- Give three reference letters of Thatched roofs that you constructed or repaired, larger than 100m².
- The institute is providing the essential services; the work must be executed in such a manner that it will not have negative impact on service delivery.
- Any damages to the Institutes equipment due to the negligence of the service provider will be repaired or replaced by the service provider at his/her own costs.
- All the work done and the material used must comply with the requirement of Occupational Health and Safety Act, National building regulation, South African National Standard and any other relevant legislation. The work must also comply with: SANS 10407- 2016 (SOUTH AFRICAN NATIONAL STANDARDS- Thatch roof construction)
- The service provider to ensure that all the work is completed within time schedule from the date the service provider received the order.
- Twine.
- The materials used shall be tar-treated sisal twine. Stitching spaced at a maximum of 110mm.

- The binding or fastening of the thatch on the battens should be in accordance with the method of thatching used, and not be spaced more than 110mm apart. The materials used shall either be tar- treated sisal twine.
3. All price quotations that have a rand value of R 30,000.00 to below R 50,000,000.00, including VAT, will be evaluated by applying the 80/20 principle as prescribed by the Preferential Procurement Policy Framework Act 5 of 2000 and its Regulations. The lowest acceptable price will score 80 points, the 20 BBEE points will be allocated as follows:
