## 1. Lifting Machinery Inspector's Experience.

The following documents are required for evaluation of bids:

- 1. An organisational chart demonstrating the key people in the organization that will be utilised on the project.
- 2. CV and copies of LMI's Qualifications.
- 3. LMI's ECSA registration should reflect the list of lifting machinery category accreditation

The scoring of LMI experience will be as follows:

Lifting tackles coverage identified for the LMIs is as per LME's category for the project. Points (60)	0	The LMI's total category coverage for lifting machinery and tackles is less than 50%.
