

**Questions and Answers Schedule for Integrated Waste Management at Cape Town International Airport, Tender reference Number: CIA 6753/2021/RFP**

Item	Question	Answer
1.	A waste compactor for non-recyclable waste to be provided as per Point 3.1.8, Provide the following equipment but the compactor on site belongs to the Airport. According to Mr Williams, we have to maintain it. Can that be put in writing please?	The compactor belongs to ACSA, but it would just make sense for the contractor to manage it as they would be using it. The contractor would have to provide the calibration certificate as part of his paperwork for auditing purposes.
2.	While we were on site at the sorting facility, we noticed that none of the waste coming into the facility is weighed. How accurate do you think the volumes provided is?	The volumes provided are accurate. After sortation the different streams of waste are baled and weighed.
3.	The tender specify colour coded wheelie bins. Mr Williams has indicate that it is only black wheelie bins that we must provide and the 1100L wheelie bins. How many 1100L wheelie bins? Can this be confirmed in writing?	The contractor would only be responsible for supplying the black wheelie bins. All other colour coded bins as well as the 1100 litre bins belong to ACSA.
4.	We will need for a roving supervisor to visit the various collection points. Will he have access to parking? Or should we cost airport parking in?	The site visit for interested bidders already took place. Prospective bidders are not allowed to enter the various collection points on their own.
5.	What is the costs involved to obtain the AVOP, Airside Vehicle permits, AVOP Course and other permits as required?	Please see attached
6.	Point 1.3.14 applicable axes. What is axes?	Typing error: it should be taxes and not axes.
7.	Page 28 refer to Sewer effluent and septic waste. Is this included in the scope of work for this tender?	The emptying of the septic tank is the responsibility of the plumbing contractor and not the waste managing contractor. Since the septic tank is inside the waste facility sortation yard, it is the duty of the supervisor to manage and notify the plumbers when the septic tank is full.



8.	Is fat trap waste included in this contract? If so, can we have monthly volumes?	Fat trap waste is stored in the 2 red wheelie bins inside the Terminal 2/Northern Service yard. The 2 bins get collected every second day or when full. The bins are taken to the waste facility sortation yard and emptied there. When collecting the full bins, we replace them with 2 clean empty bins.
9.	According to the scope of work, we have to provide colour coded wheelie bins. At the physical site meeting, we were informed that ACSA provide the colour coded wheelie bins and the service provider only black 240L wheelie bins. Please confirm.	The contractor will only be responsible for supplying the black 240 litre wheelie bins.
10.	Waste collection at the protocol lounge is included in the attached scope of work but during the site meeting we were told not to collect there. Please confirm.	Apologies, the Protocol lounge is included as 1 of the collection points.
11.	LAGS is currently a problem as liquid and aerosol waste is prohibited for landfill disposal. Do you have volumes and frequencies for this? The container at the airport for LAGS was filled with PET plastic bottles.	The skip with the LAGS waste gets emptied at least once a month or every 5 to 6 weeks.
