2. The NNR reserve the right to;

- 2.1 To amend any bid conditions, specifications, terms of reference, extend the validity period or extend the closing date of the RFQ.
- 2.2 Not to accept the lowest bid or any bid part or in whole. The NNR may award the bid to the bidder who proves to be capable of handling the services and whose bid is technically acceptable and/or financially advantageous to the NNR.
- 2.3 To award this bid as a whole or in part without furnishing reasons.

2.10 Negotiate rates submitted by bidders.

2.12 The successful bidder must ensure that all personnel working under this contract are suitably experienced prior to the commencement of services and remain in the project for the duration of the contract.

2.13 The General Conditions of Contract will apply to this bid.

3. UNDERTAKING AND OBLIGATION OF THE BIDDER

3.1 The successful bidder may, upon receipt of written notification of an award, be required to conclude a Service Level Agreement (SLA) with the NNR. The SLA may serve as a tool to measure, monitor and assess the service provider's performance level and ensure effective delivery of service, quality and value-add business for the NNR.

3.2 The successful bidder shall render all or any of the services described in the Service Level Agreement and its Annexures or in accordance with the terms of reference stipulated in the RFQ document (which shall be taken as part of, and incorporated into the proposal).

3.3 The bidder hereby agrees that the proposal shall remain binding upon receipt of acceptance by the NNR during the validity period indicated and calculated from the closing date of the bid; this proposal and its acceptance shall be subject to the terms of this bid document.

3.4 The bidder accept full responsibility for the proper execution and fulfillment of all obligations and conditions emanating from the bid documents.

- 4.2 Queries received will be responded to within two (2) working days of receiving the query.
- 4.3 The NNR will not respond to any enquiries received less than seventy-two (72) hours before the closing date and time of the bid.

5. UNAUTHORISED COMMUNICATIONS

- 5.1 Communications (including promotional or advertising activities) with staff of the NNR or advisors assisting with the RFQ Process are not permitted during the RFQ. Nothing in this clause is intended to prevent communications with staff of, or advisors of the NNR to the extent that such communications do not relate to this RFQ process.
- 5.2 Bidders must not otherwise engage in any activities that may be perceived as, or that may have the effect of, influencing the outcomes of the RFQ Process in any way.

6. IMPROPER ASSISTANCE, FRAUD AND CORRUPTION

- 6.1 Bidders may not seek or obtain the assistance of employees, contractors or advisors of the NNR in the preparation of their responses.
- 6.2 The NNR may in its absolute discretion, immediately disqualify a Bidder that it believes has sought or obtained such improper assistance.
- 6.3 Bidders are to be familiar with the implications of contravening the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004 and any other relevant legislation.

7. LEGISLATIVE FRAMEWORK OF THE BID

7.1 Tax Legislation

- 7.1.1 Bidder(s) must be compliant when submitting a proposal to the National Nuclear Regulator and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

- 7.1.2 It is a condition of this bid that the tax matters of the successful bidder are in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.
- 7.1.3 The Tax Compliance status requirements are also applicable to foreign bidders / individuals who wish to submit bids.
- 7.1.4 It is a requirement that bidders grant a written confirmation when submitting this bid that SARS may on an on-going basis during the tenure of the contract disclose the bidder's tax compliance status and by submitting this bid such confirmation is deemed to have been granted.

- 8.2.1 The National Nuclear Regulator has a detailed evaluation methodology premised on Treasury Regulation 16A3 promulgated under Section 76 of the Public Finance Management Act, 1999 (Act, No. 1 of 1999), the Preferential Procurement Policy Framework Act 2000 (Act, No.5 of 2000) and the Broad-Based Black Economic Empowerment Act, 2003 (Act, No. 53 of 2003).

9. COUNTER CONDITIONS

The bidder's attention is drawn to the fact that amendments to any of the bid conditions or setting of counter conditions by bidders or qualifying any bid conditions will result in the invalidation of such bids.

10. FRONTING

10.1 The NNR supports the spirit of broad based black economic empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the NNR condemns any form of fronting.

10.2 The NNR, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry and Competition, be established during such enquiry / investigation, the onus will be on the bidder / contractor to prove that fronting does not exist. Failure to do so within a period of 14 days from date of notification may invalidate the bid / contract and may also result in the restriction of the Bidder /contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies the NNR may have against the Bidder / contractor concerned.

11. COMPANY VETTING

SECTION 4: TERMS OF REFERENCE

1. INTRODUCTION

- 1.1 The National Nuclear Regulator (NNR) is a public entity which is established and governed in terms of Section 3 of the National Nuclear Regulator Act, (Act No 47 of 1999) to provide for the protection of persons, property and the environment against nuclear damage through the establishment of safety standards and regulatory practices.

2. PURPOSE & BACKGROUND

- 2.1 The purpose of this document is to details the specifications for Service, Repairs, Maintenance and Replacement of fire suppression and fire alarm for a period of three (3) years at the NNR Head Office in Centurion and Laboratory in Acardia.

3. SCOPE OF WORK

- 3.1 The successful service provider will be expected to provide service, repairs, maintenance and replacement of the following:
- 3.1.1 Eight Combination Fire and Extinguishant Control Panel (TECHNOSWITCH) at Head Office in Centurion.
- 3.1.2 One Combination Fire and Extinguishant Control Panel (TECHNOSWITCH) at laboratory in Acardia
- 3.1.3 Eighteen HFC 227ea gas cylinders at Head Office in Centurion
- 3.1.4 One Stat-X electrical aerosol extinguishing unit 1000grm at laboratory in Acardia
- 3.1.5 One Addresable Fire Panel
- 3.1.6 Two Heat detector (one at the Head Office and the other one at Laboratory).

3.2 The service provider will be expected to carry out the service, repairs, maintenance and replacement of the fire suppression system as follows:

3.2.1 All devices must be removed from the mounting base, stripped down and cleaned. Fault condition tested for each device to ensure the correct indication is received at the fire panel.

3.2.2 Monitoring the battery power levels to ensure correct charge levels

3.2.3 Testing the fire suppression system to ensure correct operation. This will be conducted by means of double knock fire activation with the detonator disconnected to ensure that the suppression agent does not release. Monitor all voltages to ensure the correct operation up to the detonator.

3.2.4 Testing all sounders for correct operation.

3.2.5 Test all peripheral equipment for correct operation i.e. Fire Damper and relay to shut off air flow.

3.2.6 Filling the fire log-book and note all discrepancies.

3.2.7 Rectify any faults occurred on site i.e. cable faults or broken glass, faulty detectors, faulty panel, suppression release.

3.2.8 Issue a signed service sheet.

3.2.9 Mount operating procedures next to the panel for quick and easy reference.

3.2.10 Provide a log-book as per SANS 10139 regulations.

3.2.11 Size of the suppression cylinders- 22kg model Technoswitch panel.

24. Anti-dumping and countervailing duties and rights

- him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
- 32. Taxes and duties**
- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
- 33. National Industrial Participation (NIP) Programme**
- 33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
- 34. Prohibition of Restrictive practices**
- 34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).
- 34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.
- 34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
