## **1. PURPOSE**

The purpose of these terms of reference (TOR) is to invite bidders to submit quotations for supply and installation of a CCTV point for Karoo National Park.

## **2. BACKGROUND**

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## **3. SCOPE OF WORK**

The service provider is required to supply, install, configure and commission one (1) CCTV point in Karoo National Park.

- Supply and delivery of a new CCTV Point, cabling, mounting brackets, connectors and accessories.
- Installation and configuration of the CCTV Point.
- Testing and commissioning to ensure the system is fully operational
- Replace existing battery points along Noordeinde fence line
- Surveillance points to be installed at Main gate
- Area to cover: Noordeinde to Main gate
- Provision of user training and handover report

### **Requirements**

- All equipment must be new and comply with relevant industry standards

- Installation must be completed within ten (10) working days from the date of receipt of order
- A minimum of twelve (12) month warranty on equipment and workmanship is required.
- Equipment and installation must comply with PSIRA

#### 4. SPECIAL CONDITIONS

- The General Conditions of Contract (GCC) available on the National Treasury website [www.treasury.gov.za](http://www.treasury.gov.za) will be applicable to this closed quotation.
- The scope of work shall form part of a contract
- The service provider may not assign or subcontract any part of the order without the written consent of SANParks.
- In the event that the service provider fails to deliver the required goods, SANParks retains the right to take which ever steps are necessary to alleviate the situation. This may include the involvement of other service providers, and the service provider will not have any claim because of the actions taken by SANParks.
- An official order will be issued before any goods are delivered to Karoo National Park.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim regarding preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **“price”** means an amount of money tendered for goods or services and includes all applicable taxes less all unconditional discounts.
- (c) **“Rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“The Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
