Submission of all returnable documents as listed on page 25 - 26


The adjudication is based on the following criteria

- Step 1 – Administrative and substantive responsiveness
- Step 2 - Technical evaluation
- Step 3 - Price evaluation and specific goals
- Step 4 - Approval and post-tender negotiations (if applicable)
- Step 5 - Objective criteria (if applicable)
- Step 6 –Award of business and conclusion of contract

Bidders must ensure that all the required returnable documents are submitted with their RFPs.
