TERMS OF REFERENCE FOR THE APPOINTMENT OF LABORATORY SERVICES – SMALL MOLECULES FOR THE PROVISION OF LABORATORY TESTING SERVICES TO SOUTH AFRICAN HEALTH PRODUCTS REGULATORY AUTHORITY (SAHPRA) FOR A PERIOD OF THIRTY-SIX (36) MONTHS

1. PURPOSE OF THE BID

The purpose for this bid is to call for service providers to be contracted to SAHPRA on a competitive basis for the purposes of providing laboratory services with respect to small molecules, as and when required.

2. BACKGROUND

The mandate of SAHPRA as a schedule 3A entity is to ensure the efficient, effective, and ethical evaluation or assessment and registration of medicines, medical devices and IVDs that meet defined standards of quality, safety, efficacy, and performance, where applicable. To ensure that the process of evaluating or assessing and registering medicines, medical devices and IVDs is transparent, fair, objective and concluded timeously.

As part of the monitoring object as per Section 2A of the Medicines Act, SAHPRA is required to conduct testing for the purposes of post-market surveillance (PMS) and testing for investigation of contraventions. Sampling and testing in the post-market surveillance (PMS) function is performed to ensure compliance of products to registration/authorisation requirements or conditions. SAHPRA does not have a laboratory in its structure and therefore requires the services of a laboratory to test small molecules.

3. SCOPE OF WORK

The laboratory that is appointed will provide laboratory services for testing of small molecules.

a. The score for functionality shall be calculated as follows:

- i. Each panel member shall award values for each individual criterion on a score sheet.
- ii. The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual bidder for functionality.
- iii. The **minimum technical threshold is 75 points**. Bidders that do not meet the minimum technical threshold will not be evaluated further for price and specific goals.

b. PRICE AND SPECIFIC GOALS POINTS

- i. All remaining bids will be evaluated as follows:
- ii. The 80/20 preference point system will be applied. Points for price and specific goals will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2022.
- iii. If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.
- iv. The point scored for the specific goals for each acceptable bid will now be added to the price point.
- v. The bid must be awarded to the supplier that obtained the highest preference points or may be awarded to a supplier that did not score the highest points only in accordance with section 2(1)(f) of the PPPFA.

c. ADJUDICATION OF BID

Section A 3: Evaluation Process/ Criteria

- i. The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points.
- ii. The bid must be awarded to the supplier that obtained the highest preference points or may be awarded to a supplier that did not score the highest points only in accordance with section 2(1)(f) of the PPPFA.

d. SPECIAL CONDITION OF THE BID

- The bidder must provide the list of third-party service providers it will utilise for laboratory services for small molecules and specify the tests these third-party service providers will be conducting.
- Bidders are required to submit quotes for each test or service specified in the scope of work. In addition to the tests/services listed in the terms of reference, bidders will also be required to provide quotes for any additional tests or services not listed on the scope of work. Bidders should clearly specify these additional tests/services and provide associated pricing information.
- Each quote will undergo assessment and approval based on predefined evaluation criteria. The evaluation process will consider factors such as technical compliance, pricing, delivery timelines, and quality assurance measures.
- **South African Health Products Regulatory Services** reserves the right to accept or reject any quote, in part or in whole, based on the evaluation outcomes.
