### 1.1 DESCRIPTION OF SERVICE: SUPPLY AND DELIVERY OF A DIGITAL DISRUPTOR GENIE

### **BACKGROUND:**

A disruptor genie is used to break apart mycelia and cells during DNA extractions. We currently have an old disruptor genie (only 12 samples per time) that can only shake at 1 frequency. Since more projects require molecular work an additional disruptor genie is required that can be adjusted to different frequencies. With one more disruptor genie, the speed of which DNA gets extracted and overall identification will be doubled which increases the productivity in the group. New projects on powdery mildew requires shaking at different frequencies therefore a digital disruptor genie that can be adjusted to different frequencies is required.

## **PURPOSE**

Digital disruptor genie is essential an essential laboratory equipment for researchers engaged in molecular work that are dependent upon quality DNA extraction for PCR and qPCR.
