INTRODUCTION TO SOUTH AFRICAN NATIONAL PARKS (SANParks)

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our **vision** is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our **mandate** is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our **mission** is to develop, expand, manage, and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

BUSINESS UNIT RESPONSIBLE FOR THE BID

The Tourism Division, Parks Division and Kruger National Parks are responsible for managing the various National Parks and tourism products. With over 2,200 tourism accommodation units and 7,000 tourism beds, SANParks contributes hugely to the tourism industry in South Africa.

CONTEXT OF THIS PROCUREMENT

SANParks manages a huge tourism plant and is continuously busy with upgrading and development of new products. There is an to provide standardisation of furniture, fittings and equipment for the current facilities, and to design and furnish major upgrades and new facilities as part of the various projects implemented by SANParks to develop infrastructure for the current tourism and hospitality market.

CONTRACT PERIOD

The contract is a for a period of **3 (three) years** and will be a framework agreement.

SPECIFICATIONS/SCOPE OF WORK

SANParks needs the services of **Qualified Interior Design Service Provider(s) for SANParks for a period of 3 (three) years.**

1. SCOPE OF WORK

The scope of work expected to be delivered will depend on each project, but can include the following services:

- Aid in enhancing the customer experience in SANParks establishments through design.
- Elevate the business through a cohesive crafting of spaces that are aligned with organisational brand, vision, and values.
- Aid in the selection of furniture, interior finishes, fittings, appliances, ornaments, crockery and cutlery that will enhance the feel within the space. This extends to any other aspect of hospitality interior design that will improve the business and accentuate offering.
- Make strategic and tactful use of colours and lighting that is relevant for each space.
- Create the interior layout and furniture selection and every other aspect of hospitality interior design that can contribute to the success of a business through functional design.

- Create a seamless experience by unifying architectural components, colour scheme, location, communities, environment, and brand.
- Create a standardisation specifications list for all furniture, finishes, fittings etc. to ensure there is consistent feel of spaces throughout SANParks' property.
- Work closely with project managers, project architects, internal departments of SANParks including (tourism standards and marketing) to craft and execute the project.
- Plan, design and execute interior projects.
- Provide the following to the project team: project briefing, concept drawings and vision boards, detailed drawings and specifications, final material list.
- Conduct site visits to ensure project execution aligns to the design vision.
- The design process will include the briefing of project, brainstorming with project team and SANParks representatives (including tourism standards and marketing), design of concepts according to client brief and project specifications (including budget), various meetings to unpack concept, refine the proposal, upon agreement of concept -choose material, details and confirm the budget, create final drawings, elevations, 3D renderings, mood boards and spreadsheet to be submitted to client; the project is then executed by the contractor.

SANParks intends to appoint a maximum of 4 (four) service providers. Should only 1 (one) service provider meet the criteria, the recommendation and award of 1 (one) service provider will proceed. SANParks reserves the right to appoint one or more service providers to a maximum of 4 (four).

DETAILED PRICING – SBD 3.3 Professional Services

Bidders are required to provide a detailed and comprehensive price proposal i.e.; all costs associated the bidder's proposal must be clearly specified and included in the Total Bid Price.

PRICING INSTRUCTIONS

- a) The bidder must submit a fee proposal based on Contract Value on a fictitious project provided in the Pricing Schedule for comparative pricing evaluation. Tenderers must include detail calculation of contract value fees and discount offered in the **Pricing Schedule** provided.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
