5. SCOPE OF WORK

Purchase, Collect and Removal of the stainless steel scrap at Koeberg Power Station. The quantities will only be verified once collected and weighed by the successful tenderer. The weights need to be witnessed by an Eskom official on a calibrated scale.

The purchaser must assure the site be left clean at completion of their collection and removal of the scrap stainless steel.

The scope of work will include the purchase, collect and removal of stainless steel at Koeberg Power Station. Buyers must show their interest to participate by submitting all tender returnable specified on the tender enquiry.

The purchaser will be responsible for the safe collection, handling, removal, and transportation of the **scrap within 3 days of notification of successful tender**.

It remains the responsibility of the buyer to be fully familiar with the condition of the scrap before tendering. Disputes regarding the condition of the items after tender closing will not be accepted or allowed.

The purchaser will be responsible for the safe collection, handling, removal, and transportation of the scrap as well as to clean the site, qualified labour and suitable certified plant, machinery, equipment and transport for this purpose.

Payment shall be made to Eskom no later than **two days after the date of the sale based on the actual quantity in kilograms**. The release of the scrap stainless steel to the new buyer will take place immediately after notification of successful tender and the buyer has the correct equipment/transport to collect the scrap stainless steel.

The goods on sale will be identified by Eskom.


