- 3.2. A Service Level Agreement and contract shall be concluded with the accredited service provider for a period of 36 months, and refreshed on an annual basis;
- 3.3. Bidders must submit their bids on a shelve price listing, negotiations shall be conducted with each individual company to conclude on a delivery pricing. The shelve prices shall remain valid for a period of 12 months and refreshed annually;


