TENDER 8/3/25-2026 / MN84-2026: SAFE REMOVAL OF THE PAVILION ROOF AT SMIT SPORTS GROUNDS, VELDDRIF

TENDERS are hereby invited from competent and experienced contractors for the safe removal of the pavilion roof at Smit Sports Grounds, Velddrif. **It is estimated that bidders should have a CIDB grading of 2GB or higher and must provide valid proof thereof.** CIDB registration shall be valid on the date of tender submission.

Bids, in sealed envelopes, clearly marked "**Tender No. T8/3/25-2026 MN84/2026: Safe removal of the pavilion roof at Smit Sports Grounds, Velddrif**", must be placed in the tender box at the Municipal Offices, 13 Kerk Street, Piketberg no later than **12:00 on Friday, 22 May 2026**, when the bids will be opened in public. **Bids addressed to any municipal official in his/her personal capacity will not be considered and will immediately be disqualified. It is the bidder's responsibility to make sure that bids are being placed in the tender box by courier companies. The Municipality will not be held accountable for any bids not being placed in the tender box by courier companies.**

Tenders must be valid and binding for one hundred and twenty (**120**) days after closing date

A compulsory clarification meeting will be held on **Thursday, 07 May 2026 at 11h00 at Smits Sport Grounds, 27A Iris Street, Velddrif, 7365.** The meeting will commence at **11:10** and nobody will be allowed in the meeting after the aforementioned time.

Bids will be evaluated using the Council's Supply Chain Management Policy. It is therefore compulsory that the Preference Point Claim form for the Preferential Procurement Regulations is completed in full to make application for preference points of **80 points for price, 10 points for specific participation goals and 10 points for BBEE.** The **Bid price must be VAT inclusive.**

Bidders must be registered as a prospective supplier on National Treasury's Central Supplier Database (CSD). The Tax Clearance Certificate/ Tax Compliance Status (TCS) Pin/ Centralised Suppliers Database (CSD) Registration Number must be submitted together with the bid. Failure to submit a Tax Clearance Certificate/TCS Pin/CSD registration number may result in the invalidation of the bid.

Only bids completed in **black written ink** on the original Bid documentation will be accepted. Late, incomplete or Bids submitted by facsimile or email will not be accepted. Proof of submitting a Bid will not be accepted as proof of the Bid having been received. The Municipality is not obliged to accept the lowest or any Bid submitted to it. The Municipality reserves the right to accept any Bid in full or in part. If prices offered are cost effective Council reserves the right to procure more items to take financial advantage thereof.
