1 BACKGROUND

As part of the recruitment process, Organisation Effectiveness department provides psychometric services to the organisation for recruitment, selection and development purposes.

Airports Company South Africa (SOC) Limited (ACSA) had contracted with EOH from April 2019 for a period of 36 months. Due to the effect of covid-19, the organisation had to implement a recruitment moratorium. The services of EOH were not utilised for over 16 months.

As a result, EOH requested for an early termination of their services. The contract was terminated 31 October 2021.
