1. INTRODUCTION

The Atlantis Special Economic Zone (ASEZ) was officially designated in October 2018. The success of the ASEZ rests on strong collaboration across the public and private sector spectrum. The promulgation of the ASEZ was enabled through collaboration between the Department of Trade and Industry (DTI) and Western Cape Government (WCG)'s Department of Economic Development and Tourism (DEDAT), Wesgro and the City of Cape Town (CoCT). Initially inspired by the City of Cape Town's Green Technology Manufacturing Hub, these parties are working together to facilitate the development of the SEZ in Atlantis.

The ASEZ is a keystone initiative that sits within the country's broader green economy industrial development strategy. It thus both supports and draws on these initiatives. Ultimately, Atlantis needs to operate as a viable industrial hub within a thriving green economy and contributing to green technology industrialisation and job creation in South Africa. It is an important development intervention tool to unlock green industrial development, manufacturing, employment, technology development, enterprise development and skills development, amongst other opportunities expressed in the green sector strategies, policies and plans of government.

2. SPECIFICATION

Background and Purpose

The ASEZ has two offices; one in Atlantis at the Atlantis Foundries Business Park which accommodates 35 people and has a central kitchen, and one office in Century City, Cape Town and accommodates 15 staff which has a communal kitchen.

COFFEE MACHINE SOLUTION

The ASEZ requires two coffee machine solutions at its offices for its staff.

Requirements

a. Atlantis Foundries Business Park – Main Office

1. To cater for 35 people.
2. Preferably a modernised multi-function machine.
3. Must be a bean fed coffee machine.
4. Must offer various options ie, Coffee, Cappuccino, Americano, Lattes, Tea, etc.
5. Must have milk frothing, which can be separate for milk to be poured in.
6. Capable of be programmed to various cups and mug sizes.

b. Century City – Admin Office

1. To cater for 15 people.
2. Preferably a modernised multi-function machine.
3. Must be a bean fed coffee machine.
4. Must offer various options ie, Coffee, Cappuccino, Americano, Lattes, Tea, etc.
5. Must have milk frothing, which can be separate for milk to be poured in.
6. Capable of be programmed to various cups and mug sizes.

c. Bean requirements

1. The ASEZ requires a high-quality premium bean for the duration of the contract. The ASEZ reserves the right to change the bean during the contract should the quality of the bean change.

2. The replenishment of beans should be done monthly or prior to stock being finished.
Delivery costs of beans is for the bidder's account.

d. Setup and Installation

1. There is currently no water connection points in either kitchen, so to install points will need to be plumbed to the location of the machines. All plumbing and installation of machines and related costs to be covered by the bidder. Bidders will be welcome to conduct inspections of the area with prior arrangement. This must be done prior to closing date of the RFQ.
2. Once the installation has been completed, staff must be trained on how to use machines of which 2 staff members must be given detailed troubleshooting training in the event of machine failure or malfunction.

e. Maintenance and Servicing

1. The contract must have a maintenance agreement included to cover unwarranted breakages, malfunctions or failure as well as the required interval servicing for the machines for the duration of the contract.
2. Successful bidder must be able to provide support with a minimum turnaround time of 24 hours from date of call logged.

A plug and play solution whereby machine has to be manually filled with water and milk and only requires and electrical point to be connect and to function.

- To Supply, Deliver, Install 2 coffee machines as well as supply the coffee beans for 12 months at The Atlantis Special Economic Zone Soc Ltd.

WATER COOLERS SOLUTION

8.8.2. The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;

8.8.3. In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 6.1, the contractor may be required to furnish documentary proof to the satisfaction of the purchaser that the claims are correct;
