INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represent biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

BUSINESS UNIT RESPONSIBLE FOR THE BID

The business unit responsible for this bid is the conservation department at the Tsitsikamma Section of the Garden Route National Parks which is responsible for security operations within the park

CONTEXT OF THIS PROCUREMENT

The purpose of this bid is to invite prospective bidders to submit a bid for the provision of the security guard services at the Tsitsikamma section of the Garden Route National Park.

CONTRACT PERIOD

The Contract will be for a period of three (3) years

TERMS OF REFERENCE/SCOPE OF WORK

SITES TO BE GUARDED

The security guard services shall protect SANParks employees, information and assets against any damages, injuries, vandalism, theft, sabotage, death and any other security risk or threat.

- Daily execution of access and control at the specified areas as indicated by the Park Management
- 1. Patrol and safeguard buildings and areas as indicated below, seven days a week from

18h00 to 07h00 at Stormsriver Mouth:

- Main entrance gate (guards will be stationed at this gate)
- Reception, Administration offices, technical stores complex, Admin Parking area, Otter room, Otter Parking area, Paul Sauer-Hoek residential houses.
- 2. Patrol and safeguard buildings at Tsitsikamma Big Tree seven days a week from 17h00 to 07h00
- 3. Patrol and safeguard buildings at Nature's Valley Rest camp seven days a week from 17h00 to 07h00

4. The following sites will be patrolled and safeguarded when the need arises

- a vehicle will be required

- Otter Camp area including service centre, oceanites (as and when required).
- Dolphin Camping area (as and when required)
- Restaurant area, Beach area, Guest houses and Petrusville (as and when required)
- o Stormsriver Village offices, when required
- Stores complex, when required
- o Bloukrans complex, when required
- o Tower houses, when required

DUTIES OF SECURITY GUARDS/SERVICE PROVIDER

- Gate control at the main entrance gates, record all visitors and vehicles entering and leaving the Park.
- Conduct random searches on all vehicles entering and leaving the Park, keep records of vehicles movement.
- Compile reports of incidents of security breaches taking place during shift operations.
- Carry out lawful security instructions/orders issued by identified SANParks representatives from time to time.
- React and report any emergency situations to the Senior Section Ranger/ Hospitality Services Manager/ Duty Manager or any SANParks official immediately when the emergency occurs.
- Assist with reporting of emergency to relevant emergency services, e.g. ambulance services, fire department, police station in the absence of SANParks official(s).
- Ensure that the security registers are completed, neat and up to date at all times.
- The Company must ensure quality service by adhering to SANParks operational plans and instructions. Operational plan and specific needs/duties/instructions will only be discussed with the successful bidder.
- Guards must be well trained in security services and must have traceable references, provide proof of security guards appointed.
- Ensure Guards appointed have no criminal records.
- Guards must be able to communicate in English and at least one other South African language (official)

• Minimum Guards quantity and grade per site at all times.

- a. Stormsriver Mouth Main gate: 2 x grade C guards.
- b. Natures Valley Rest Camp: 2 x grade C guards.
- c. Big Tree: 2 x grade C guards
- d. Site or Shift Supervisor: with at least Grade C (Supervisor may form part of the 6 Grade C guards required above)
- e. On Ad hoc basis, 2 grade C security guards will be required for a period of 30 days/ one month per year.

- Guards must wear the Security company uniform and be presentable at all times.
- The Security Company is responsible for transportation and conduct of the guards.
- Ensure compliance with all relevant legislations pertaining to a National Park including Occupational Health and Safety Act and regulations, Basic Conditions of Employment Act and security guards services.
- Guards will be expected to perform certain administrative duties in terms of access control and assistance with after hour visitor's attendance.

Copyright and Intellectual Property

All background intellectual property (existing prior to this contract) invests in and remains the sole property of the contributing party to this contract and/or the contracted discloses the same to SANParks at the commencement of this contract

The contracted supplier grants SANParks a fully paid up, irrevocable, non-exclusive, and transferable licence to use its background intellectual property including the right to sub-licence to third parties in perpetuity and to the extent that SANParks requires for the exploitation of the contract intellectual property and to enable SANParks to obtain the full benefit of the contract intellectual property.

The parties agree that all right, title, and interest in the contract intellectual property rightly invests in SANParks and to give effect to the foregoing:

- (a) The contracted supplier hereby assigns all rights, titles, and interests in and to the contract intellectual property that it may own to SANParks and SANParks hereby accepts such assignment, and
- (b) The contracted supplier undertakes to assign in writing to SANParks all contract intellectual property and which may invest in the contracted supplier.

The contracted supplier shall keep the contract intellectual property confidential and shall fulfil its confidentiality obligations as set out in this document.

The contracted supplier shall assist SANParks in obtaining statutory protection for the contract intellectual property at the expense of SANParks wherever SANParks may choose to obtain such protection. The contracted party shall procure where necessary the signatures of its personnel for the assignment of the contract intellectual property to SANParks, or as SANParks may direct, and to support SANParks, or its nominee, in the prosecution and enforcement thereof in any country in the world.

The contracted supplier hereby irrevocably appoints SANParks to be its true and lawful agent in its own name, to do such acts, deeds, and things and to

execute deeds, documents, and forms that SANParks, in its absolute discretion, requires in order to give effect to the terms of this clause. The rights and obligations set out in this clause shall service termination of this contract indefinitely.

Confidentiality

The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with SANParks and after termination of its involvement with SANParks, the recipient shall not:

- (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks:
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and

(c) All material embodiments of the contract intellectual property. The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein. Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
