#### General Information

#### Withdrawal may be made as follows:

On Demand - Use the withdrawal form obtainable from all Postbanks

Payment will be made only to the rightful account holder or duly appointed nominee. Withdrawal from the account of a child under seven years of age is made only to the father, mother or legal guardian. A birth certificate of adoption must be produced. Minimum of two signatories for group account must be present for a withdrawal and closeout. One signatory for a joint account may make withdrawals, but both must be present during closeout.

#### Consult your Branch Manager for further information on:

- 1. Amount that may be withdrawn on demand of-line situations
- 2. Current interest rate
- Current account fees
- 4. Period which must elapse before cheque deposits may be withdrawn

Note: Please notify your local Postbank 24 hours in advance for withdrawals exceeding R4000
