- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

1. BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 12 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

2. REQUEST FOR QUOTATION AND SCOPE

Iziko requires a service provider who specialises in plumbing services in identifying the cause of low water pressure and fixing of the problem in WC and Basins at Iziko Social History Centre Museum including unblocking of 1 urinal at Iziko Slave Lodge.

2.1. Requirements

- Perform thorough inspection to identify the cause of the low water pressure, leaks and unblocking of urinals.
- Ensure compliance with regulations and safety standards
- Record repairs, testing, and certification.

2.2. Compliance

The service provider must adhere to the Occupational Health and Safety Act and environmental regulations.

The work to be undertaken will be at all Iziko Social History Centre and at Iziko Slave Lodge. Please include in your quotation:
