DETAILED TECHNICAL SPECIFICATION

1. BACKGROUND

The SABC is South Africa's national public broadcaster. The company's objectives are to provide a comprehensive range of distinctive programmes and services with the view to inform, educate, entertain, support and develop culture in all 11 official languages. Currently, the company's principal activities comprise of Television and Radio broadcasting utilising 19 radio stations and 5 television channels. All these offerings should be kept running for 24 hours a day in line with the mandate and agreed strategic operations parameters of the organisation.

The SABC has to maintain presence across the South African landscape, it therefore own properties in eight of the nine Provinces which are occupied for business operations purpose. The offices require various maintenance initiatives be implemented in order to keep them in a good operational state furniture fittings and replacement from time to time. Furthermore, there is a need for restoration of leased-in premises to its original state when SABC vacate those offices.

The SABC completed a major waterproofing project in all roof surfaces in the Auckland Park Campus in September 2016. The initial scope of work entailed the removal of existing waterproofing, checking of screed, and application of new torch-on waterproofing system and the application of UV resistant coating. Following the commencement of the works the scope was revised to include installation of vent pipes for slab out gassing and casting of concrete anchor blocks in arear where applicable.

The current maintenance plan requires that the waterproofing surface be painted once in every three year-period in order to prolong the economic lifespan. The continuous maintenance of the roof is also in line with the guarantee's requirements. It must however be stated that during the recent heavy rains, there were few areas of the roof which have been found to be leaking and where not covered by any guarantees as there were not part of the initial scope of the major waterproofing project. These areas require to be repaired with immediate effect.

It has also been observed that the existing gutter and down pipes or drainage system requires service and repairs in order to handle the volume of water discharged by the roof.

2. SCOPE OF SERVICE

List of Areas in this phase

- TV News Building (4,000m²)
- TV Parkade Building (6,000m²)
- TV Centre Painting of balustrade and hand rails around the building (2000m²)
- Transport Building (1,200m²) - GSM Carports & Guard House (1,200m²)
- Outside Broadcast Building (OB) (1,200m²)
- Radio Park Building Reception Area (1,200m²)

Detail Activities Preparation of Roof Surfaces

- Remove all foreign objects,
- Unblock all of drains
- Inspect Parkade Building skylight feature as is also causing water leaks
- Repair skylight visible only areas reflecting evidence of damages areas
- Replace skylight seals at TV Parkade (measuring 400m²)
- Wash entire surfaces thoroughly using water and strong brush in order to remove all loosely bound contaminants and poorly adhering paint
- Apply a quality Etch cleaner to all exposed metal in order to dissolve any surface oxidation and remove any contamination - Apply bonding where required, sand affected surface and re-wash surface
- Apply a primer or Fired Earth Extreme Roof to the prepared surface using a roller (wool or Synthetic type); brush or by airless spraying.
- Two coats are recommended for optimum durability and quality of finish. Allow the first coat to cure for at least 2 hours before applying the final coat.
- Gutters or downpipes: Apply a primer or Fired Earth Extreme Roof to the prepared surface by brushing. A small fine foam roller may also be used
- Apply a primer or Fired Earth Extreme Roof to the prepared surface using a roller (wool or Synthetic type); brush or by airless spraying. Two coats are recommended for optimum durability and quality of finish. Allow the first coat to cure for at least 2 hours before applying the final coat.
- Apply two coats of similar to the existing quality and colour combination (Pro-struct 684/4 grey paint or similar) suitable for corrugated iron roofs
- The scope of works for area 27b entailed cleaning of roof sheeting, priming of sheeting, waterproofing
- to all sheeting junctions with an acrylic system, isolated repairs of gutters (excluding downpipes),

- Waterproofing of gutters with an acrylic system and re-coating of the area.
- Gutters or downpipes: Apply a primer or Fired Earth Extreme Roof to the prepared surface by brushing. A small fine foam roller may also be used
- Painting of columns, windows frames and palisade around Parkade Building

GSM Building Covered Parking (65 bays + 4 small rooms)

- Remove and disposed old damage gutters
- Supply and install similar gutters or drainage system (975 m X 20mm)
- Prepare roof surface painting - Painting of columns/pillars around Carports
- Apply paint the same way done to all the corrugated iron roofs

NB: A safety file will be required before the commencement of work

Vendors must state in writing in their quotation to the SABC that all provided information, including price, will be valid and applicable for 90 days from the date the vendor quotation is received by the SABC.

5. COSTING

The quotation must reflect a detailed cost breakdown, and any indirect costs associated with the delivery of the required service. ***The RFQ rates shall be fixed and remain firm for the duration of the contract.***

6. EVALUATION CRITERIA

6.1 BBBEE and Price

The RFQ responses will be evaluated on the 80/20-point system

6.2 Technical Evaluation

6.2.1 The tender submission will be technically evaluated out of **75 points**

6.2.2 A threshold of **60** out of **75** has been set.

6.2.3 All bidders achieving less than the set threshold of **60 points out of 75 points** will not proceed to the next phase and not be evaluated for BBBEE & Price.

6.2.4 SABC further reserve the right not to award this RFQ to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.

6.2.5 Bidder's non-compliance to this mandatory requirement will be declared non-responsive.

7. ADJUDICATION USING A POINT SYSTEM

- 7.1 The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder
- 7.2 Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- 7.3 In the event that two or more bids have scored equal points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 7.4 However, when functionality is part of the evaluation process and two or more bids have scored equal points for B-BBEE, the successful bid must be the one scoring the highest score for functionality
- 7.5 Should two or more bids be equal in all respect, the award shall be decided by the drawing of lots.

8. POINTS AWARDED FOR PRICE

- 8.1 Bidders who qualify as EME's in terms of the B-BBEE Act must submit a certificate issued by a verification Agency accredited by SANAS for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates or DTI Affidavit.
- 8.2 Bidders other than EMEs must submit their original and valid B-BBEE status levels verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a verification agency accredited by SANAS.

- 8.3 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate
- 8.4 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 8.5 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 8.6 A tenderer will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intend sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended Sub-contractor is an EME that has the capacity and the ability to execute the sub-contract.
- 8.7 A tenderer awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capacity and the ability to execute the sub-contract.

9. COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

10. CONDITIONS TO BE OBSERVED WHEN TENDERING

- 10.1 The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- 10.2 No tender shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.
- 10.3 The Corporation reserves the right to:

Not evaluate and award submissions that do not comply strictly with his RFQ document.

Make a selection solely on the information received in the submissions and

- 10.3.1 Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
- 10.3.2 Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.
- 10.3.3 Award a contract to one or more bidder(s).

10.3.4 Accept any tender in part or full at its own discretion.

10.3.5 Cancel this RFQ or any part thereof at any time.

10.3.6 Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BBBEE & Preference Point system.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

Bid rigging is, therefore, an agreement between competitors not to compete.
