### **BID NUMBER**

#### **1. INTRODUCTION AND PURPOSE**

The purpose is to appoint a service provider for the supply and delivery of printing paper for dot matrix printers to Tshwane Market for the period of twelve months

#### **2. BACKGROUND**

The market utilises market agents to source produce from the producer and to sell such produce on the producer's behalf to buyers. The produce remains the property of the farmer until the produce is sold and the market agent acts as his agent.

Transactions to purchase produce on the Tshwane Market can only take place if a buyer has a valid buyer's magnetic tag and an account with the market. A buyer opens an account after which a buyer's magnetic tag is issued.

The market's sales hours are from 05:00 to 10:30. During this time system support is of critical importance. An average of 13 636 sales transactions are processed daily with an average turnover of R13million per day. All clearances, payments, pay-outs, reports, and statistics are done on the system in the interest of producers, agents, buyers, and market management. Two types of dot matrix printing paper for the centralised dot matrix printers in the service centres and line printers situated at the IT data centre are required.

Centralised dot matrix printers at the two client service centres are used by buyers daily to print summary sheets for their daily purchases on the market. The dot matrix printing paper is important to ensure the smooth functioning of the market's daily operations and a shortage thereof will disrupt such operations.

### **3. PROJECT SCOPE**

The different dot matrix paper will be distinguished as follows in the scope of works:

- a) ITEM 1: Papers for Office Dot Matrix Printers
- b) ITEM 2: Papers for Heavy Duty Line Printers

### **4. GENERAL CONDITIONS**

#### **4.1 Packaging (ITEM 1 & 2)**

- a) The supplier shall provide such packaging as is required to prevent damage or deterioration of the dot matrix printing paper during transit to or during storage at the market facility.
- b) The packaging shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage.
- c) Packaging, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' destination.
- d) Each box that is supplied must contain at least 2000 sheets.

#### **4.2 Warranty (ITEM 1 & 2)**

- a) The service provider must warrant that the dot matrix printing paper supplied in this contract are new, unused and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract.
- b) The service provider must further warrant that all dot matrix printing paper supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- c) This warranty shall remain valid for the duration of use of the specific batch delivered by the supplier to the market.
- d) Should any defect in a single batch be detected by the market, the service provider must replace the total batch within seven (7) days.

- e) If the supplier, having been notified, fails to remedy the defect(s)/ replace the batch delivered within the seven (7) day period, the market may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.
- f) Wherever possible, items and materials shall comply with the relevant South African Bureau of Standards Specifications. The service provider, when using materials conforming to a Standard Specification shall, if called upon, furnish the Employer with certificates of tests showing that the materials do so conform.
- g) The Tshwane Market will be authorised to submit samples on their own account to verify compliance to the requirements of the specification during the extent of the tender period.

#### 4.3 Delivery period

- a) The service provider must be able to deliver dot matrix printing paper within two (2) weeks after a purchase order has been issued.
- b) The service provider must further keep enough dot matrix printing paper in stock, as agreed with the market, to prevent any possible delays in the supply thereof.

## 5. TECHNICAL SPECIFICATIONS

### 5.1 Branding/Labelling

#### 5.1.1 ITEM 1: Papers for office Dot Matrix Printers

The tender must supply and deliver dot matrix printing paper that are plain on the reverse side and branded/labelled with the City of Tshwane logo on the front side thereof. Different patterns of arts can be introduced

The successful service provider must be able to deliver an estimated amount of 150 boxes of dot matrix paper with 2000 pages per box per year on an as and when required basis and according to the listed specifications. The following requirements inter alia need to be adhered to by the service provider and proof thereof will be required as stipulated below:

- a) Paper density: 58 grams per square metre (gsm)
- b) Paper Size; 305mm x 203mm
- c) 24 Sprocket Dot Matrix Printer Paper Pin Fed. Continuous with perforations

It should be noted that the amount can change according to the needs of the Tshwane Market.

#### 5.1.2. ITEM 2: Papers for Heavy Duty Line Printers

The tenderer must supply and deliver dot matrix printing paper without colour and logo. The successful service provider must be able to deliver an estimated amount of 120 boxes of dot matrix paper with 2000 pages per box per year on as and when required basis and according to the listed specifications.

The following requirements inter alia need to be adhered to by the service provider and proof thereof will be required as stipulated in paragraph 3 of the scope of tender:

- a) Paper density: 58 grams per square metre (gsm)
- b) Paper Size; 280mm x 368mm
- c) 22 Sprocket Dot Matrix Printer Paper Pin Fed. Continuous with perforations

**It should be noted that the amount can change according to the needs of the Tshwane Market.**

### **6. CONDITION**

Samples for ITEM 1 & 2(Papers for Heavy Duty Line Printers and Papers for office Dot Matrix Printers)

Service providers will be required to present samples within two (2) weeks after the appointment letter is issued to ensure that it is according to the standard required by the City of Tshwane. The quality of the logo must be maintained for the full duration of the contract period and any deviation from it will activate the points set out in paragraph 4.2 of the scope of tender.

### **7. STAGES OF EVALUATION**

The bid will be evaluated in two Stages namely:

- **Stage 1:** Administrative Compliance
- **Stage 2:** Preference Points System

#### **7.1 Administrative Compliance**

All the bids will be evaluated against the administrative responsiveness requirements as set out in the list of returnable documents.

#### **7.2. Preference Points System**

The Preferential point system used will be the 80/20 points system in terms of the Preferential Procurement Policy Framework Act, 2000(Act 5 of 2000) .

The city of Tshwane reserves the right to conduct market analysis. Should the city exercise this option, Where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the tenderer if they will be able to deliver on the price, if a tenderer confirm that they cannot, The tenderer will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.

- (a) **“all applicable taxes”** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- (b) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (c) **“B-BBEE status level of contributor”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (d) **“bid”** means a written offer in a prescribed or stipulated form in response to an

invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;

- (e) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003) as amended by Act No 46 of 2013;
- (f) **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- (g) **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- (h) **“contract”** Error! Bookmark not defined. means the agreement that results from the acceptance of a bid by an organ of state;
- (i) **“EME”** means an Exempted Micro Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (j) **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- (k) **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- (l) **“non-firm prices”** means all prices other than “firm” prices;
- (m) **“person”** includes a juristic person;
- (n) **“QSE”** means a Qualifying Small Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 ( Act No. 53 of 2003);
- (o) **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- (p) **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- (q) **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- (r) **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- (s) **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.



### 3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

### 4. POINTS AWARDED FOR PRICE

#### 4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

##### 80/20

$$P_s = 80 \left( 1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P<sub>s</sub> = Points scored for comparative price of bid under consideration

P<sub>t</sub> = Comparative price of bid under consideration

P<sub>min</sub> = Comparative price of lowest acceptable bid

### 5. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTION

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 A bidder who qualifies as an EME in terms of the B-BBEE Act must submit a sworn affidavit confirming Annual Total Revenue and Level of Black Ownership.
- 5.3 A Bidder other than EME or QSE must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.

- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
