1. <u>Definitions</u>

In these Conditions of Bid, words and expressions shall have the meanings assigned to them in the various parts of the Bid Documents and in addition, the following words and expressions shall have the meanings assigned to them hereunder:

2. <u>INTERPRETATION</u>

2.1. APPLICATION

These Conditions of Bid govern the submission and adjudication of proposals and the acceptance by the Council of any proposal. They shall not form part of nor be interpreted or construed as forming part of any subsequent Contract as may result from the acceptance by the Council of any Bid received, nor shall these Conditions of Bid have any force or significance in any such subsequent Contract.

2.2. LANGUAGE

These Conditions of Bid shall be interpreted in the English language.

2.3. GOVERNING LAW

All Bids, as well as the adjudication thereof and the acceptance of any bid shall be subject to the law of the Republic of South Africa.

2.4. SINGULAR, PLURAL AND GENDER

In these Conditions of Bid, words importing the singular include the plural and words imparting the masculine include the feminine and neuter and vice versa where the context requires.

2.5. <u>HEADINGS AND SUB-TITLES</u>

The clause headings and sub-titles in these Conditions of Bid shall not be deemed to be part thereofnor be taken into consideration in the interpretation or construction thereof or of the Conditions of Bid.

2.6. SCHEDULE AND FORMS TO BE COMPLETED BY THE BIDDER

- 2.6.1. Bidders must complete the proposal Documents where entries by the Bidder are required, inindelible black ink, and notice must be taken that tip-ex or any other corrective measures may not be used in the document.
- 2.6.2. All alterations must be initialled by the authorised submitter.



2.7. AMENDMENTS TO THE BID DOCUMENTS

2.7.1. AMENDMENTS BY THE BIDDER

- 2.7.1.1. Bidders shall not make any unauthorised amendment or addition to any part of the text or content of the proposal Documents. If any such unauthorised amendments, alterations or additions are made by the Bidder, these will be deemed to be of no force or significance in the Bid and will be ignored in the evaluation and adjudication of the Bid.
- 2.7.1.2. Any point of difficulty in the interpretation of the Bid Documents must be clarified with the Council as early as possible during the Bid Period. If a query by any Bidder is found to be of significance, the Council will inform all Bidders accordingly as soon as possible.

2.7.2. <u>AMENDMENTS BY THE EMPLOYER</u>

- 2.7.2.1. The Council shall be entitled, at any time prior to the Closing of Bids, to make any variation, amendment or addition to, or omission from the Bid Documents, including to the time and date set for the Closing of Bids, by the issuing of an Addendum (or Addenda).
- 2.7.2.2. Any Addendum so issued shall be deemed to form part of the Bid Documents and shall be communicated in writing to all parties who have acquired the Bid Documents from the Council.

No variation by the Council of the Bid Documents will be of any force or effect unless set out in an Addendum as described above, despite the fact that a variation of or amendment to the Bid Documents may have been implied in or may reasonably be inferred from any other document issuedor statement made by the Council.

3. <u>SIGNING OF BID</u>

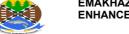

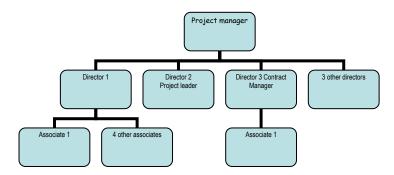

C2.1 SCOPE OF WORK

BACKGROUND

The below work should be delivered in sequential phases, with the earlier phases informing subsequent phases,

REVENUE OPTIMISATION PROJECT (The Turnaround Strategy)

1. PURPOSE

The project purpose [The Revenue Optimization Project] is aimed at assisting the municipality with regards to data cleansing in order to determine the collectable and uncollectable amounts as well as proposals for write-offs where necessary particularly on the household debts; through ensuring that the municipality has a reliable revenue data and physical visits of the unmatched and deceased to inform final write off amount recommended on the outstanding debt. Experience has shown that revenue for clients with incorrect / incomplete contact information cannot be collected on time or not be collected at all. Currently minimal collections also do contribute to the municipality's cash flow to an extent where the municipality is having shortfall for normal operations.

The indigent status of each consumer (where applicable) also needs to be reviewed by either physical audit or external verification checks so that if a household is found to have provided fraudulent information to the municipality regarding any material condition for registration as an indigent such person should be removed from the register of indigents. The municipality also needs assistance in updating its current indigent policy.

2. CURRENT STATE

The municipality is currently confronted with continuous increase of historical debt and current debt to a certain extent but, in a nutshell, the value of these debtors is very questionable and cannot currently be justified.

Also, the ongoing growth of debtor listing to all the areas under the municipality's jurisdiction requires a clear set of rules and procedures in relation to naming convections (farms, suburbs, and extensions), debtor groupings, the linking of services and service infrastructure and data loading authority levels to protect the data purity and continued completeness.

Data integrity within the municipal debtors' book is very questionable and thus some debtors are not even aware of the outstanding debt. The invoices and statements might be going to incorrect addresses, which is resulting in further fruitless expenditure therefore the municipality is not just loosing from the revenue collections but again must bear losses on the administration of these debtors.

Municipal consumer debt has several potential impacts. It can cripple the cash position of this municipality and, therefore, its ability to fulfil constitutionally mandated responsibilities. Outstanding payments also represent foregone resources that could be used to improve the living conditions of the poor. Possible reasons as to why this type of debt arises are various and our municipality needs to find out.

The current basic challenge is that presently the municipality is that the data is not reasonably arranged and managed with much needed and imperative information for collection purposes missing, there is a definite need to identify incomplete, incorrect, inaccurate, irrelevant etc. parts of the data and then replacing, modifying or deleting the incorrect data which will: -

- · Boost or support effective debt collection procedures
- · Result in accurate debtor's book and
- Shall provide the basis of the indigent register



3. SCOPE OF WORK

- (a) The ideal service provider must have innovative ideas which will assist in revenue management and improve the municipality's low collections from its debtors.
- (b) Assistance is also required to perform a door-to-door survey to ascertain critical billing information particularly for the unmatched and deceased that will come out of the desktop exercises that will be concluded during the 1st Phase of this project. The requirement here is that local labour must be used for this door-to-door survey.

- Analyze the arrear debt in the municipal books to determine whether there are accounts that are untraceable, inaccurate, etc. and require some writing offs or any adjustments.
- Clearly determine collectable vs uncollectable where there is almost zero chance of recovering monies owed (& so that our resources are not wasted by focusing on debt that is highly uncollectable)
