1 BACKGROUND

As part of the SALGA's digital strategy for local government – Connected Citizenry is a critical ingredient towards modernised and smarter municipalities. The associated framework further calls for a laser-focused approach to customer and user journeys, customer and user experiences, while encompassing various customer-triggered services. Some of these services address specific programmes that promote local economic development. Small businesses being the cornerstone of economic development, job creation, and citizen prosperity – it is critical for their compliance requirements to be handled with efficiency, speed, and a data-centric approach. To this end SALGA requires the co-development of a No-code/Lo-Code platform to serve as an permitting and licensing engine

2 SCOPE OF WORK

The appointed services provider is expected to provide SALGA with a customisation no-code and low-code platform for addressing permit and licensing processes with the following:

2.1 Application and Registration Processing

Enable the application, approval, and tracking of applications for permits and/or special licenses.

2.2 Rule-based Features aligned with Policies and Bylaws

With data handling and workflows for:

- Applications handling, with “Save and complete later” capabilities
- Document Attachments
- Data Validation
- Exception handling with appropriate routing and re-routing
- Email and text notifications (for both user and applicants)

2.3 Off-Line Capabilities | Assisted Service

Enable offline available for data capturing with the capability for submission-upon-connectivity.

Enablement of assisted capturing where municipal staff can capture on behalf of applications.

2.4 User Access and Security

Implement comprehensive role-based access control, multi-factor authentication, and integration with approved security solutions for monitoring and intrusion prevention.

- Ensure user verification to prevent authorised access.
- Data protection layer for any data classified as Personal and Sensitive

2.5 Integration and Interoperability

Provide integration capabilities to connect with municipal finance and enable data exchange, ensuring interoperability and future scalability – in particular to billing for applications for permits or licenses.

Provide a backend database replication to the SALGA Datawarehouse/lake and/or direct integration into SALGA's Datawarehouse/Lakes/Lakehouses.

2.6 API and MCP Ready

Embed architecture nimble for integration into and from-to existing Applications (APPs) hosted in platforms such as Microsoft Azure, AWS, GCP and Huawei-cloud; including being embedded seamlessly into other web-applications.

Embed architecture that supports Model-Context-Protocols for the integration of AI models and agents housed in GCP and AWS – in both language, workflows, and data validation.

2.7 Smart Document/Barcode/Certifications/Identifications

Enable the generation of unique smart barcodes linked to approvals and permits – either within the platform through seamless integration (as per 2.6)

2.8 Validation on Demand

Enable search and retrieval for research and validation purposes by authorised and approved users and stakeholders (with dynamic results based on user-privileges).

2.9 Reporting and Audit Trails

Generate standard and custom reports, dashboards, and maintain a full audit trail of all transactions and system activities for accountability and compliance, to ensure the municipalities are in line with governance requirements.

3 BIDDER REQUIREMENTS

3.1 Specifications and requirements

- The bidders will be expected to demonstrate technical ability and capability to develop and maintain a customisable, cloud-based LO-CODE/NO-CODE platform utilising interoperable technologies that can function in a broader ecosystem in a multi-cloud environment.
- Furthermore, the bidders will be expected to demonstrate the platform's Artificial Intelligence capabilities, OR at the very least, the platform's capability to incorporate Artificial Intelligence.
- The bidders must demonstrate the deployment of LO-CODE/NO-CODE development in both public entities (i.e. commercial state-owned entities and/or municipalities).
- The bidders must own or at least have exclusive control of the platform through an official license.

In addition, the following principles – in line with SALGA Digital's framework – will be expected:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
