South African National Parks invites prospective bidders for The Construction of 10 New Family Chalets and Infrastructure at Lendlovu Lodge Phase One in Addo Elephant National Park, Eastern Cape

The following tenderers who are registered with the CIDB, or are capable of being so registered prior to the evaluation of submissions are eligible to submit tenders:

- Contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations, for a **7 GB** or **6 GBPE** or **Higher** rating of construction work, are eligible to have their tenders evaluated.
 Joint ventures are eligible to submit tenders provided that:
 - (i) Every member of the joint venture is registered with the CIDB;
 - (ii) The lead partner has a contractor grading designation in the **7 GB** or **6GBPE** or higher class of general building construction work; and
 - (iii) The combined contractor grading designation calculated in accordance with the Construction industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a **7 GB** class of general building construction work or a value determined in accordance with Regulation 25 (1B) of 25(7A) of the Construction Industry Development Regulations

Tenderers are informed that a contract participation goal is included for sub-contracting of local EME's and QSE's that are 51% black owned and located within Sundays River Valley municipal area.

SANParks has identified the following specific goals to advance the categories of persons as part of its procurement processes:

This tender will include functionality as part of the evaluation criteria, tenderers shall further be required to satisfy the following functionality (quality) criteria and be required to demonstrate their ability to undertake the work and to provide proof of experience, expertise and personnel to undertake work of this nature. Tenderers are required to score a minimum of **17 points out of a possible 24 points (70%)** in order to be responsive. Tender Data, of the proposed functionality criteria and point system for evaluation with points being awarded in accordance with the following provisions:

- a) General Building Construction Experience (maximum 12 points)
- b) Technical Expertise and Competency (maximum 12 points)

Bids that do not meet the minimum qualifying score of 70% (17 points) on the functionality criteria listed above will not be considered for further evaluation.

before submitting their tender as to the form and nature of the Site, the quantities and nature of the work and materials necessary for the completion of the Works and the means of access of the Site, the accommodation they may require and in general shall themselves obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect their tender.

The tenderers must be represented at the site inspection by a person who is suitably qualified and experienced to comprehend the implications of the work involved. Attendance of the site inspection is compulsory and a tender will be disqualified if the site inspection is not attended by a representative of the tenderer.
