## Background

Medupi Power Station will be required to receive and treat raw water from the Crocodile West Scheme, with elevated organic concentrations. The organics will have to be removed prior to the demineralisation step to protect the downstream plant as well as the boilers and turbines.

The rental and demonstration of an advanced oxidation system to oxidise the organic matter in the Medupi feed water being supplied from the Crocodile West River. The supplier will have to demonstrate that the technology offered could oxidise/mineralise the organic matter present in the Medupi feed water

## Scope of work

1. The rental of a pilot AOP system able to treat water from Crocodile West River in a batch process that can treat batches of water between 20 and 50 litres.

2. The AOP system should contain the following:

- AOP reactor
- Raw water clarifier
- c. Dosing facility
- d. Pumps and valves
- e. UF membrane module
- f. RO membrane module
- g. Pressure and flow indicator
- h. Activated carbon bed
- Hoses and line should be of a flexible material

All the above shall be appropriate for the test flow rate as determined by the contractor.

3. The preferred AOP process is available via the use of peroxide and uv

4. Preference is given to the layout: clarification→UF→AOP reactor→carbonfilter→RO. The installed clarifier at Medupi was designed based on the incoming raw water flow. It is 25% under-designed. The additional 25% will be the result of the UF backwash, this will hence result in an overflow from the clarifier. This overflow might have high turbidities associated with it and could inadvertently decrease the UV system efficiency if located immediately after clarification.

5. The supplier shall supply Eskom with cost estimate for:

- Quote for AOP system, which entail the test work being carried out on the supplier's premises. Eskom technician/s will deliver the relevant water and work with the supplier's project team and cover duties highlighted in the scope of work section of this document i.e observation, sampling, analysis and transport of samples to Eskom RT&D.
6. Delivery, installation and commissioning of the unit should not exceed 3 months. i.e test work must be completed within 3 months (from the start date, 5 days a week, excluding public holidays, running 8 hours)
7. The supplier shall perform jar tests to determine appropriate dosing of aluminium chlorohydrate (ACH)
8. Submission of a process flow diagram of the system clearly defining the battery limits

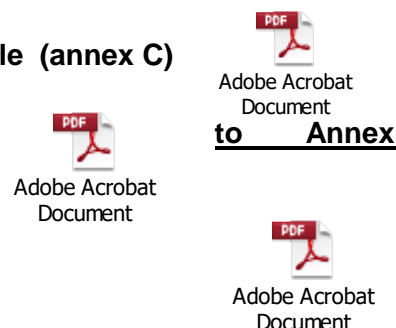
