

**PROJECT DESCRIPTION: OCCUPATIONAL HEALTH MEDICAL SURVEILLANCE**

**SUPPLY CHAIN MANAGEMENT**

**END USER: PRASA TECHNICAL RISK**

**1. OBJECTIVE**

The purpose of this is to ensure that all workers are fit for and suited to the work they are to do and meet the inherent health requirements for the relevant occupation.

To monitor employee's health at work and ensure that the health of employees is not adversely affected by their work or working environment.

To ensure compliance with Occupational Health and Safety Act No. 85 of 1993 and Railway Safety Regulator Act No. 16 of 2002 (Element 12 Human Factors Management).

**2. BACKGROUND INFORMATION**

There is no dedicated on-site clinic to conduct medical surveillance on employees at the Rolling Stock Maintenance Depot. This has created a need to procure the services of an external service provider to provide services related to medical surveillance.

**3. SCOPE OF WORK**

Conduct Occupational medical surveillance to the PRASA Technical Rolling Stock Maintenance Employees at the following Depots by 30<sup>th</sup> October 2024:

- a) Braamfontein – Gauteng (56 employees)
- b) Bloemfontein - Free State (02 employees)
- c) Durban – Kwa-Zulu Natal (04 employees)
- d) Culemborg – Western Cape (26 employees)
