TERMS OF REFERENCE

APPOINTMENT OF TRANSACTIONAL ADVISOR TO CONDUCT COMPENSATION AND BENEFITS POLICY ANALYSIS AND RECOMMEND ALIGNMENT WITH PUBLIC SERVICE INCLUDING DETERMINATION OF COST IMPLICATIONS FOR A PERIOD NOT EXCEEDING THREE (03) MONTHS

1. Background

During one of its meetings, the Board resolved that the migration of policies, especially those with compensation and benefits be looked at and be aligned to those of the Department of Public Service and Administration.

In order to achieve the above objective the entity seeks to appoint the transactional advisor to analyse the current operational and remuneration environment as well as make recommendations to the Board. The Service Provider to accomplish the following for the entity:-

1. Ensure that the HR compensation and benefits policies of the entity are analysed, and incorporated in line with Public Service Regulations. This implies that all applicable policies including those that are linked to compensation and benefits, or systems based will have to be analysed for alignment with those of the Public Service.
2. Ensure that a project plan and time frames are developed to guide the process.
3. Ensure that applicable legal process flow, and systems are revised and aligned to support the recommendations.
4. Conduct research with other public entities whose employees belong to Government Employee Pension Fund (GEPF), Government Employee Medical Scheme (GEMS) and or using the compensation and benefits policies that similar to the public service.
5. Ensure that overall, the migration will be in compliance with applicable legislations and regulations.

The key pillars that form the basis for the alignment of policies are as follows:-

1. Limpopo Tourism Act No. 4 of 2018.
2. Public Services Act and its regulations (1994 as amended).
3. LTA current HR policy manual (Applicable chapters on compensation and benefits).
4. Recognition agreements in place between LTA and its recognised Union.
5. Administrative processes regulating Salary Structure, UIF, Provident Fund, medical aid and grading system.
6. Applicable systems (such as payroll and leave, PMS, admin systems versus PERSAL, EQUATE).
7. Labour Relations (Consultation processes).

2. Administration

- a. LTA to supply the applicable gradings of the positions including the salary structure
- b. LTA to supply the Provident fund rules and regulations
- c. LTA list of medical aids and their members
- d. LTA to supply systems and contractual obligations of the payroll and admin systems (Sage VIP)

3. Rights and Obligations

- a. Where applicable the rights and obligation of affected employees are to be in line with Section 197 of the Labour Relations Act. (Annexure A)
- b. Employees should not be put in a worse off situation that they were in prior to the process.

4. Scope of Work

- a. The development of a project plan to be signed off by the entity.
- b. Establish a task team in consultation with LTA management which will coordinate the process.
- c. Consultation with the Board, Staff and relevant stakeholders.
- d. Review the LTA compensation and benefits policies
- e. Analyse the remuneration structure of LTA, including remuneration reports arising from the pending Re-organisation Development process (if concluded),

- available reports on Benefits provided by Government as well as other public entities aligned to Government.
- f. Determine the quantum for medical aid subsidy, housing, provident or pension funds benefits.
 - g. Review and recommend remuneration policy amendments.
 - h. Analyse and propose on the conversion in line with to Government system of Basic plus benefits for the applicable levels with financial implications based on the remuneration data of employees.
 - i. Produce progress and close out reports.

Special Conditions

2. EVALUATION METHODOLOGY

In accordance with the Preferential Procurement Regulations, 2022, the bid evaluation process shall be carried out in three Phases namely:

The minimum qualifying score for functionality is **60%**. Bidders who fail to obtain the minimum qualifying score of **60%** will be disqualified.

PHASE 3: EVALUATION IN TERMS OF PRICE AND PREFERENCE POINT SYSTEMS

Only bids that achieve the minimum qualifying score/percentage for functionality will be evaluated further in accordance with the 80/20 preference point system prescribe in Preferential Procurement Regulations, 2022.

The PPPFA prescribes that the lowest acceptable bid will score 80 points for price. Bidders that quoted higher prices will score lower points for price on a pro-rata basis.

When calculating prices:

- Unconditional discounts will be taken into account for evaluation purposes; and
- Conditional discounts will not be taken into account for evaluation purposes but would be implemented when payment is affected.

- a. The points scored by a tenderer in respect of the specific goals above must be added to the points scored for price.
- b. A specific goal will be allocated according to the percentage of ownership in the company (e.g., if black people own 50% of the company, the points for the specific goal will be 2, i.e. $50/100 \times 4 = 2$).
- c. Only the tender with the highest number of points scored may selected.
- d. CSD report will be used to as a means of verification of the specific goals.
- e. **A valid medical certificate is required to claim points for persons with disability.**
- f. Confirmation of registration on the National Military Veterans Database of the Department of Military Veterans is required in order to claim points for military veterans.
- g. Limpopo Tourism Agency reserves the right not to award the bid.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

4.6. I, the undersigned, who is duly authorised to do so on behalf of the company/firm, certify that the points claimed, based on the specific goals as advised in the tender, qualifies the company/ firm for the preference(s) shown and I acknowledge that:

- i) The information furnished is true and correct;
- ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;
- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
