1. INTRODUCTION AND PURPOSE

The City of Tshwane Metropolitan Municipality invites suitably qualified service providers to submit proposals for the provision of a 24-hour Employee Wellness Helpline for a period of one year with the purpose of providing tele-counselling and referral services to employees and their immediate family dependents.

2. BACKGROUND

Employee Wellness: A holistic support service

The City of Tshwane Employee Wellness service offers a holistic and confidential psycho-social support, counselling and work-life interventions to employees and their immediate family dependants.

The primary focus is on the improvement of productivity and the general emotional wellness of employees through early diagnosis, prompt, and proactive wellness intervention.

Immediate benefits associated with implementing Employee Wellness services include:

- Reduced absenteeism
- Reduced health-related costs
- Reduced risk costs
- Increased productivity
- Increased morale and motivation
- Improved organizational reputation.

3. PROJECT SCOPE

To invite suitably qualified service providers to submit proposals for the provision of a 24-hour Employee Wellness Helpline for a period of one year.

Services to be included for in a 24-hour Employee Wellness Helpline are:

1. Telephone counselling (for both employees and their immediate family dependents). There should be a call centre facility operating 24/7/365 and the service should be provided in all eleven (11) South African official languages to include, but not limited to interventions in the following areas:
 - Stress and anxiety
 - Relationship Issues
 - Financial wellness
 - Organizational Issues
 - Absenteeism
 - Adjustment Problems
 - Substance dependency
 - Telephonic Psycho-social counselling
 - Critical incidence stress and trauma debriefing
2. Ongoing telephonic managerial consultation and referral
3. Referrals for internal Wellness intervention and to external resources
4. The bidder must demonstrate thorough understanding of the objectives and deliverables of this project.

4. DELIVERABLES

- A 24hr Employee Wellness Helpline and tele-counselling support service in all eleven official languages with a dedicated Toll-free number.
- Call back / please call service.
- Online wellness and marketing of the 24hr helpline
- Monthly usage report
- Quarterly trends report
- Referrals for internal Employee Wellness service as well as to external service providers.

5. CONDITION

- Bidder to ensure compliance to OHS Act no. 85 of 1993
- Bidders to submit detailed project plan with proper timelines, milestones, and the methodology on how the service will be rendered, implementation and managed.
- The bidder must provide a comprehensive action plan for the implementation including turnaround times on how this will be achieved.

- (f) **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- (g) **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- (h) **“contract”** Error! Bookmark not defined. means the agreement that results from the acceptance of a bid by an organ of state;
- (i) **“EME”** means an Exempted Micro Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (j) **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- (k) **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- (l) **“non-firm prices”** means all prices other than “firm” prices;
- (m) **“person”** includes a juristic person;
- (n) **“QSE”** means a Qualifying Small Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (o) **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- (p) **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- (q) **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- (r) **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- (s) **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

P_s = Points scored for comparative price of bid under consideration

5. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTION

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 A bidder who qualifies as an EME in terms of the B-BBEE Act must submit a sworn affidavit confirming Annual Total Revenue and Level of Black Ownership.
- 5.3 A Bidder other than EME or QSE must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating

issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.

- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.

CERTIFICATE OF INDEPENDENT BID DETERMINATION
