- Design and construct platforms, low pressure pipeline and small pump stations,
- Provide multi-disciplinary project management,
- Procurement from multiple suppliers, and
- Commission and handover the infrastructure to Dube TradePort Corporation and project beneficiaries

NB* The four co-operative farms are located at Nyoni, Mandeni, Marianhill and Richmond.

It is estimated that tenderers must have an active CIDB contractor grading designation of **CIDB grading of 3CE** or higher by the closing date of the bid. **No PE status is allowed (CIDB grading 2CE PE will not be acceptable).**

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The bid shall apply preferential procurement from enterprises that are 51% Black Women Owned and 51% Youth Owned.
