As incidents and events are **Location Specific** the mobile app records the GPS Latitude and Longitudes to be later used with the CiiMS platform for further analysis. This will then align to an already existing **Locality** structure which in turn results in location specific rule sets.

The mobile app will trigger event specific **Escalation Procedures** based on the type of event and location. This will ensure that the user who is reporting it via the interface will respond to all relevant questions in that moment. This enables detailed reporting with situational accuracy and aids in preserving and retaining

The event or incident is further enhanced by an ability to add **Attachments** such as photographs or recordings that may be taken or uploaded as the incident is reported.

CiiMS Go will furthermore have an ability to capture various **Checklists** against which the operation and activities can be measured and controlled. These checklists will ensure that the operation is running efficiently and where exceptions are identified they are automatically escalated and addressed through structured processes on the connected CiiMS platform.

- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
