The Municipality does not bind itself to accept the lowest formal quotation or award a contract to the bidder scoring the highest number of points. Formal quotations will be evaluated in terms of the 80/20 Preference Point System prescribed by the Preferential Procurement Policy Framework Act (Act5 of 2017) and the Municipality's Supply Chain Management Policy.
