1 BID OVERVIEW

1. Mountain Zebra National Park aims to be the pride and joy of SANParks. The park will be able to achieve this by developing and managing a system that represents the biodiversity, landscapes, and associated heritage assets of the park for the sustainable use and benefit of all.
2. A competitive bidding process will be embarked upon. It is also important for SANParks to assist Government in its key objective of socio-economic development, especially in rural areas, where many of the national parks are located.

3 LEGISLATIVE AND REGULATORY FRAMEWORK

8.2 Phase 2: Functionality Evaluation Criteria

- Bidders are required to demonstrate their ability to undertake the required services and provide proof of expertise and resources to provide the required services.
- Bidders are required to score a minimum of **8** points out of a possible **12** to proceed to the second stage/phase of evaluation
- Bid offers that fail to score the required number of points (**8**) per the functional requirements will be eliminated.
