1. Background

The SABS is a statutory body established in term of Standards Act, 1945 (Act No. 24 of 1945) and continues to operate in terms of the Standards Act, 2008 (Act No. 8 of 2008) as the national standardization institution in South Africa, mandated to:

- develop, promote and maintain South African National Standards;
- promote quality in connection with commodities; and
- render conformity assessment services and matters connected therewith.

2. Request for Quotation (RFQ)

This RFQ serves as an invitation to submit a quotation **for the appointment of a panel of service providers to provide shuttle and transportation services** subject to the SABS Standard Terms and Conditions, of which a copy is available on www.sabs.co.za, **accessible through the link: https://www.sabs.co.za/Procurement/proc_toc.asp**

The Bidder is requested to supply its quotation, in writing, by the date specified. Should the Bidder require any clarification, the clarification should be submitted by e-mail to the Procurement Specialist identified in this document.

By submitting a quotation in response to this RFQ or participating in this RFQ process, the Bidder accepts that it is subject to and bound by all the terms and conditions contained in this RFQ document.

3. Confidentiality

This document may not be used for any purpose by the Bidder other than for developing their response to it, and all reasonable efforts must be taken by the Bidder to ensure confidentiality of any information provided. This document and any other information of a confidential nature provided to the Bidder during the course of RFQ process are and will be covered by the non-disclosure agreement to be signed between the SABS and the Bidder.

4. No Contract

Bidders shall note that this RFQ does not commit the SABS to any course of action resulting from the receipt of quotations and the SABS may, at its discretion reject any submission which does not conform to instructions and specifications which are contained herein or select a Bidder based upon its own unique set of criteria. The SABS also reserves the right not to select a bidder.

Nothing in this document shall be construed as a contract between the SABS and the Bidder, and no communication, whether verbal or written, by the SABS personnel or agents during the course of this process shall create such a contract in respect of the requirements specified in this RFQ.

5. No Obligation to Proceed

The SABS reserves the right to discontinue the RFQ evaluation process at any time and will not be responsible for any losses incurred by the Bidder as a result of discontinuance of the RFQ process

6. Validity of Proposals

The Bidder's quotation shall remain valid for a period of one hundred and twenty (120) days from the closing date. The SABS may at any time prior to the expiry of the bid validity period, extend the above validity period by sixty (60) days by written notice to the Bidders. In that event, the SABS will not require any consent from the Bidders, and bidders will not be required or permitted to amend any of their quotations.

The SABS retains the right, but is under no obligation, to request Bidders to extend the validity periods of their quotations, prior to expiry thereof, if it has already invoked the extension referred to above and it is in the SABS' interest to further extend the bid validity period. Such request shall be in writing. The Bidder is not obliged to extend the validity period. Also, bidders will not be required or permitted to amend any of their quotations.

7. Scope of Work

7.1 Background

The SABS seeks to appoint a panel of service providers for corporate shuttle and transportation services for an upcoming ISO TC 147 meeting involving **200 delegates**. The event will take place in Pretoria, with delegates accommodated across multiple hotels in the city and surrounding areas. Reliable, safe, and well-coordinated transportation services are required to support airport transfers, daily conference movements, official dinners, and evening shuttle services.

This RFQ seeks qualified transportation service providers with proven experience in handling large delegations, multi-route logistics, and time-sensitive schedules.

7.2 Scope of Required Transportation Services

a) Airport Transfers (Arrival and Departure)

Transportation will be required for **arrival and departure transfers** between the airport and the official delegate hotels.

Arrival Transfers (12 and 13 April 2026)

From airport to the following hotels:

- The Capital
- Protea Hotel Fire & Ice Menlyn
- The Maslow Time Square
- City Lodge Lynwood
- Other Hotels (within 10 km radius of CSIR)

Departure Transfers (17, 18 and 19 April 2026):

- From the above hotels back to the airport on the day of departure.

Service provider should note the following:

- Delegates arrivals and departures will be at different times and shuttle service should be able to accommodate this.

- Meet and greet coordination and luggage handling support may be required.
- A dispatch and coordination desk is preferred during peak arrival and departure periods.

b) **Daily Conference Transportation**

Delegates will attend daily meetings at the **Council for Scientific and Industrial Research (CSIR)**.

Requirements:

- Morning transport from all listed hotels to CSIR.
- Afternoon/evening return transport from CSIR back to hotels.
- Punctuality and adherence to a fixed daily schedule are critical.

c) **Official Event Transportation**

i. Cocktail Dinner (13 April 2026)

- Transportation from all hotels to SABS Groenkloof Campus.
- Return transport to hotels following the dinner.

ii. Cocktail Gala Dinner (15 April 2026)

- Transportation from all hotels to The Garden Venue in Randburg.
- Return transport to hotels following the dinner.

iii. Excursion – Randwater (16 April 2026)

- Transport 30 delegates from CSIR to Gautrain Station in the afternoon (13:00pm - 14:00pm)

The service provider must allow for the following:

- Coordinated departures across hotels.
- Flexible return times depending on program flow.

d) **Daily Evening Shuttle Services**

Daily evening shuttle services will be required between delegate hotels and Menlyn Mall.

Key requirements:

- Scheduled shuttle rotations during evening hours.
- Pick-up and drop-off points clearly communicated to delegates.
- Services to run for the full duration of the event.

7.3 Fleet and Operations Requirements

Service provider should propose an appropriate mix of the following cars:

- Luxury coaches (50–65 seaters)
- Midi-buses
- Minibuses or shuttles

All vehicles must:

- Be roadworthy, licensed, and fully insured

- Be air-conditioned and well-maintained
- Include professional, uniformed, and experienced drivers
- Accommodate delegates with luggage where applicable
- Include provision for **at least one accessible vehicle** for delegates with mobility needs

7.4 Coordination, Safety and Compliance

The appointed service provider will be expected to:

- Appoint a dedicated transport coordinator.
- Provide a detailed transportation schedule and routing plan.
- Maintain real-time communication during operations.
- Comply with all local transport regulations.
- Carry comprehensive passenger liability insurance.
- Adhere to health, safety, and contingency protocols.

8. Evaluation Criteria

Mandatory Requirements

a) Experience or Track Record of the Service Provider.

- Bidder must submit a minimum of 3 contactable reference letters on the client's letterhead confirming the provision of shuttle services within the past 5 years.
- The reference letters should include but not limited to the following information:
 - Client name and contact details.
 - Contract description and service performed.

b) Drivers Valid Professional Driving Permits (PDP) and Valid Driver's License for Each Driver.

- Bidder must submit a list of all drivers and a copy of each drivers valid professional driving permits and valid driver's licenses.
- The shuttle company must have a minimum of 5 professional drivers.

c) Valid Public Liability Insurance Cover or Passenger Liability Insurance,

- Bidder must submit a valid letter confirming that the business is insured.
- The letter must be on the insurance company letterhead.

d) Company Vehicles or Lease Agreements

- Bidders must submit proof of ownership, such as company's vehicles certificates and vehicle ownership either in the name of the company or director's name.
- In terms of leased vehicles, an agreement letter of the lease agreement must be attached.
- Bidders must submit a list of proposed vehicles at offer.
- Bidders must have a minimum of Luxury coaches (50–65-seater), Small Passenger (10-14-seater), Economy Sedan (4-seater) on the list. ***NB This is strictly for comparative purposes or evaluation purposes and not the only cars that the service provider will be expected to offer.***

Only bidders that submitted and/or met all the mandatory required documents will be evaluated further on preference point system (price and specific goals).

10. Preference Points

Only Bidders who quoted as per mandatory requirements will be evaluated further on 80/20 preference points system of 2022. (Pricing and Specific Goal).

Important Notes:

- Price must be quoted in South African currency and must be inclusive of VAT.
- The rate per kilometer will be used for evaluation purposes. This is strictly for comparative purposes, and a route log sheet shall be maintained by the service provider and/or driver for invoicing purposes.
- Google Maps will be utilized to calculate the distance of the trip from pick up point to drop off point (Shortest route as per Google Maps will be utilized).
- For the purpose of determining the kilometers travelled, the departure point shall be determined from CSIR to the pickup destination then from the pickup destination to the drop-off destination.
- Weekdays refer to Monday to Friday.
- Normal working hours are from 07:00am to 17:00pm.
- Ater hours refer to any time not included in the “normal working hours” above.
- Fixed price, where foreign currencies are involved, bidders should make provision for forward cover.

12. Reservations and Panel Appointment

- SABS reserves the right to appoint 1 or more service providers who qualify to be part of the panel.
- Minimum number of 1 and maximum number of 5 service provider(s) will be appointed on the panel.
- A ranking based on preferential point system will be allocated to the service providers, with the service provider that scored the highest on preferential point system being ranked first (1) and the service provider that scored the lowest on preferential point system will be ranked last.
- Service provider(s) that ranked from 1 to 5 will be appointed on the panel.
- SABS reserves the right to negotiate the rates with service providers.

13. Contact information

All enquiries regarding this RFQ must be e-mailed/directed to lerato.monyepao2@sabs.co.za and 012 428 6055. Bidders must not contact any other SABS’ personnel regarding this RFQ, as it may lead to the Bidder’s disqualification. Also note that any canvassing by Bidders/Suppliers regarding this RFQ will result in disqualification.

14. Late Submissions

- Late submissions will not be accepted.
- Submission emails received after submission date and time will be considered late bid submission and will not be accepted for consideration by SABS.

- SABS will not be responsible for any failure or delay in the email transmission or receipt of the email including but not limited to:
 - File size.
 - Receipt of incomplete bid.
 - Delay in transmission receipt of the bid.
 - Illegibility of the bid.
 - Security of the bid data.

15. Advance payment

The SABS will not make an upfront or advance payment to a successful Bidder. Payment will only be made in accordance to the delivery of service or goods that will be agreed upon by the SABS and the successful Bidder.

16. Responsibility for costs

Under no circumstances shall the SABS be responsible for any of the Bidder's costs associated with the preparation and/or submission of its quotation, including any costs incurred by the Bidder prior to the signature, by both parties, of an agreement resulting from a successful bid.

17. Bidder's contractual terms

The SABS will not be bound by any legal or contractual terms as may be included in the Bidder's quotation, in response to this RFQ.

**PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL
PROCUREMENT REGULATIONS 2022**

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

NB: BEFORE COMPLETING THIS FORM, TENDERERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF THE TENDER AND PREFERENTIAL PROCUREMENT REGULATIONS, 2023

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

a) The applicable preference point system for this tender is the **80/20** preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 **To be completed by the organ of state:**

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

Table 1: Specific goals for the tender and points claimed are indicated per the table below. Bidders that do not claim points will be allocated 0 points.
