### **1. INTRODUCTION AND PURPOSE**

Quotation for the supply, delivery and offloading of Insecticides and rodenticides to the poison store (S010).

### **2. BACKGROUND**

The Quote will be used to stock the Poison Store (S010) with essential insecticides and rodenticides.

These essential insecticides and rodenticides are used by various Departments to control rats in offices, clinics, electrical substations and especially at the market. The Insecticides are used to control cockroaches and ants in municipal buildings and termites on sidewalks.

The essential insecticides and rodenticides will be procured over a period of 1 year on an as and when required basis.

The Department is seeking one bidder to supply all the products on the quote for a period of 1 year.

### **3. PROJECT SCOPE**

#### **3.1 SUPPLY AND DELIVERY OF THE PRODUCTS**

- Delivery will only be allowed by appointment only. Prices must therefore include delivery charges.
- Delivery must take place within 10 working days after the vendor has received the official purchase order form from the City of Tshwane.
- Labour for off-loading must be supplied by the vendor and poison to be off loaded inside the store.

- All containers must be intact as no damaged containers will be accepted.
- The weight or volume must be exact as to what is stated on the labels.
- Containers must be sealed as prescribed in Section 9(1) of the Law on Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act 1947 (Act 36 of 1947) - Regulations regarding fertilizers.
- All Labels must comply with the following specifications. No product will be accepted if it does not comply with these specifications. The manufacturer's label must remain on the container. No poison may be decanted into smaller containers. Vendor must supply the Trade name product to be offered.
- The labelling during transport as well as the transport of Poisons must be in accordance with:
  - ☐ SANS 10228: 2003: The identification and classification of dangerous goods for transport.
  - ☐ SANS 10229: 1996 Packaging of dangerous goods for road and rail transportation in South Africa.

### 7.1 ADMINISTRATIVE COMPLIANCE

## 7.2 MANDATORY COMPLIANCE

The quote will be evaluated as follows:

- The quote will be awarded as a whole.
- Bidders who fail to hand in the label for any specific item will result in their quote being disqualified.
- The trade name, the registration numbers and labels must be supplied as per the tables of products below and must match in trade name and manufacturer.
- Only South African registered insecticides and rodenticides may be quoted.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.

9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
