2 CONDITIONS OF BID

- 2.1. No bid will be accepted from persons in the service of the state as defined in the Municipal Finance Management Act and Regulations.
- 2.2. The bid terms and conditions remain binding to the bidder throughout the contracting period.
- 2.3. A consideration of this bid is subject to governing legislation, including those relating to B-BBEE, the City's development goals, Preferential Procurement Policy Framework Act 5 of 2000 and its Regulations as amended.
- 2.4. That the tender may not necessarily be awarded to the bidder scoring the highest points.
- 2.5. The bidder is prohibited from participating in any form of price manipulation or bid rigging including those in MBD 9. If found, the bidder will be disqualified, or award be terminated.
- 2.6. Negotiations will only be conducted with selected bidder/s where necessary.
- 2.7. An award may be made to more than one bidder.
- 2.8. If considered necessary, the municipality reserves the right to visit the bidder's place of business and/or its customers.
- 2.9. The specifications are the copyright of the municipality.
- 2.10. The municipality reserves the right to cancel the requests for bids at any time or stage before the award or not to accept any bid.
- 2.11. Should it be found that the bidder has not been truthful and/or dishonest, then municipality shall cancel the award and negotiate with the next acceptable bidder.
- 2.12. All bids will be treated as confidential to the extent that the Municipality is required by law to publish or make information in the bid available to a third party.
- 2.13. Any dispute arising out of or relating to the bid must first be referred to the Accounting Officer for resolution.

2.14. Remedies

- (1) If an organ of state is of the view that a tenderer submitted false information regarding a specific goal, the City of Johannesburg will —
 - (a) inform the tenderer accordingly; and
 - (b) give the tenderer an opportunity to make representations within 14 days as to why the tender may not be disqualified or, if the tender has already been awarded to the tenderer, the contract should not be terminated in whole or in part.
- (2) After considering the representations referred to in subparagraph (2.14) (b), the City of Johannesburg may, if it concludes that such information is false—
 - (a) disqualify the tenderer or terminate the contract in whole or in part; and
 - (b) if applicable, claim damages from the tenderer.

2.15. The tender may be divisible and be awarded to more than one bidder.

2.16. The City reserves the right to award the bid in full, partially or not at all.

3. TERMS AND CONDITIONS FOR BIDDING [Part B – Tax Compliance Requirements]

- 3.1. Bidders must ensure compliance with their tax obligations.
- 3.2. Bidders are required to submit their unique personal identification number (PIN) issued by the South Africa Revenue Services (SARS) to enable the organ of state to view the taxpayer's profile and tax status.
- 3.3. Application for the tax compliance certificate (TCC) or pin may also be made via e-filing. In order to use this provision, taxpayers will need to register with SARS as e-filers through the website www.sars.gov.za.
- 3.4. Foreign suppliers must complete the pre-award questionnaire in 3.7 below.

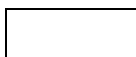

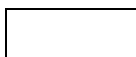

5. GENERAL TERMS AND CONDITIONS OF THE CONTRACT

- a) In this document words in the singular also refer to the plural and *vice versa* and words in the masculine also mean in the feminine and neuter.
- b) The General Conditions of Contract (GCC) will form part of all bid documents and may not be amended.
- c) Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the GCC. Whenever there is a conflict, the provisions in the SCC shall prevail.
- d) Wherever the following words appear, they will have interchangeable meaning: "purchaser" refers to the "municipality" and "supplier" refers to the "bidder".

Definitions

- 1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.

Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery *ex stock*" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad markets its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "*Force majeure*" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.

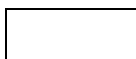

- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

- 5.3. Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.

The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.3. This warranty shall remain valid for 12 (twelve) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for 18 (eighteen) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
- 15.4. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s).
- 21.3. As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.4. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.5. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the supplier fails to perform any other obligation(s) under the contract; if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

1. BACKGROUND

Public swimming pools are essential facilities within the City of Johannesburg Metropolitan regions communities, providing recreational opportunities, promoting health and wellness, and serving as venues for swimming education and sports. The City of Johannesburg manages approximately 100 swimming pools across its seven regions. The monthly consumption of swimming pool chemicals varies seasonally, with higher usage typically occurring in the warmer months (spring and summer) when pool activity increases. During these peak seasons, there is a greater demand for chemicals like chlorine, pH adjusters, and algaecides to maintain water quality and safety. In contrast, chemical usage decreases during the cooler months (autumn and winter) due to reduced pool activity and lower water temperatures. The city monitors and adjusts chemical procurement accordingly to meet these seasonal demands, ensuring efficient and cost-effective management of the pools.

As per the Supply Chain Management Policy 2023, the City and its Entities are required to source goods, works and services at competitive market prices for cost effectiveness and this entails an end-to-end analysis of the market, the industry, and the market prices, as per Section 217 of the Constitution which requires a fair, equitable, transparent, competitive and cost-effective process. Swimming pools use chlorine to purify swimming pool water to meet the standards required as well as for the utilisation by the public. The output of the above outcome is to ensure that the pools meet the required standards and expectations of the communities they serve.

For the purposes of water purification in the public swimming pools, the City of Johannesburg has been using the acid calcium base and liquid gas chlorine as these dosing derivatives are the most relevant for the in-land purification. Chlorine is the chemical most often used to keep swimming pools free of bacteria that can be hazardous to humans. As a halogen (salt forming), chlorine is a highly efficient disinfectant, and is added to public water supplies to kill disease-causing pathogens, such as bacteria, viruses, and protozoans,

In line with the State procurement principles, the City wishes to realize the economies of scale on the services rendered and the interested bidders should take the volumes outlined above into account when preparing their financial offers.

Community Development, Sport Recreation (aquatics) is to ensure safe, accessible, and well-maintained public swimming pools throughout all seven regions within the City of Johannesburg jurisdiction. Manage swimming pools sustainably, focusing on environmental responsibility. To maintain the quality and safety of the water in these pools, the procurement of appropriate chemicals.

- (n) The vehicle/s used for delivery by road shall be capable for negotiating normal curves and of entering a doorway of 3.1m in height by 3.3m wide.

- (o) The supplier must ensure that the transport vehicle comply with all other applicable legislation in accordance with the National Road Traffic Act 93 of 1996, chapter VIII of the Regulations and all Legislative Requirements SANS 1028.
- (p) Hazardous substances and chemicals must comply with the standards and requirements as prescribed in the National Road Traffic Act and SANS.
- (q) The supplier will be held responsible for any damage to Municipal property either due to bad handling of the equipment or due to failure or any other malfunction of the cylinders.
- (r) In the event of contaminated or sub-specification product being delivered to treatment sites the Tenderer will also bear the cost of flushing, cleaning, repairing, and re-commissioning all pipelines, dosing pumps and equipment, flow and mass measuring systems and/or other valves and appurtenances.
- (s) Quality records must be maintained for reference by any credible external body Standards for packaging, storage, and handling of products to be maintained.
- (t) The successful tenderer shall negotiate with companies to hire equipment and machinery while their own machinery is being serviced or repaired. No downtime will be accepted for equipment breakdowns.
- (u) The facilities must always be kept in a neat, clean, tidy, and safe condition and must be used in accordance with the Occupational Health and Safety Act (OHSA), (85 of 1993).
- (v) When work is completed, the respective site must be cleaned of all surplus materials and equipment must be removed from site. All areas of work must be left in a neat and tidy condition to the satisfaction of the client.

6. SERVICE LEVEL AGREEMENT

The successful bidder(s) will be required to enter into a Service Level Agreement with the City of Johannesburg. Supplier(s) Note that performance will be reviewed on a monthly basis and penalties might be imposed for under performance and poor performance.

7. ADDITIONAL REQUIREMENTS UPON AWARD OF CONTRACT

- i) Proof of comprehensive insurance on all vehicles, tools, and equipment must be submitted within a period of 21 days
- ii) Certified copies of vehicles roadworthy certificates must be submitted to the city.

8. DURATION

The contract is for a period of 36 months from the effective date.

9. MINIMUM REQUIREMENTS FOR EVALUATION: SUPPLY AND DELIVERY OF SWIMMING POOL CHEMICALS:

Minimum Requirements for Evaluation

To be considered for further evaluation, bidders must meet the following minimum requirements:

9.1 Vehicles Licensed to Deliver Hazardous Chemicals:

Bidders are required to submit valid proof of vehicles that are licensed to transport hazardous chemicals. Acceptable evidence includes documentation for vehicles that are owned, rented, or leased. The vehicles must be suitable and legally authorized for the delivery of hazardous chemical substances.

9.2 Similar Projects Successfully Completed:

Bidders must provide a list of previously completed projects that are specifically related to the supply and delivery of pool chemicals. Each listed project must be supported by a reference letter on the client's company letterhead as proof of successful delivery and performance.

9.3 Approach and Methodology:

Bidders are required to submit a comprehensive safety plan that demonstrates their understanding and management of chemical safety practices. The safety plan should include a risk assessment, hazard identification procedures, safe work procedures, and an emergency response plan to show preparedness in handling hazardous chemicals.

9.4 Qualification of the Bidder:

The bidder, or personnel assigned to the project, must possess a relevant qualification at NQF Level 2, such as a National Certificate in Chemical Operations or an equivalent qualification in a related field. Proof of this qualification must be submitted as part of the bid.

10. EVALUATION CRITERIA

Proposals will initially be evaluated in terms of administrative compliance, followed by functionality and in respect of the Preferential Procurement Regulations 2022 using the 80:20 points system.

Only bidders that score 70 points or more in total will be evaluated further on pricing offer. Functionality Criteria will be evaluated in terms of the 80:20 Preferential Points System, where a maximum of 80 points will be awarded for price and a maximum of 20 points will be awarded in accordance with the City preferential goals.

11. Functionality Criteria

Functionality will be evaluated over two phases namely Phase 1 and Phase 2. Phase 1 will be based on Vehicles Licensed to Deliver Hazardous Chemicals, Similar Projects Successfully Completed, Approach and Methodology, Qualification of the Bidder and Phase 2 will be based on pricing/ financial offer.

Only bidders that score **70 points or more**
