BACKGROUND

TCTA's Land and Rights Acquisition ("LRA") seeks to commence with the registration of land and rights acquired in the implementation of The Olifants Rivier Water Resources Development Project (ORWRDP)). The process spans over various stages, from early acquisition planning through to registration of transfer/cession of acquired land and rights. Acquisition of land and rights is completed, and the rights are due for registration. The Legal Department requires the appointment of an external service provider from the established list of preferred service providers to execute the work.

The service provider shall be expected to carry out all tasks related to the determination of the value of the rights registrable to the extent that it is required in administering the registration of the rights. Time spent on the task shall be billable under task 2 (two) of the pricing schedule.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
