## 3 PROPOSAL SUBMISSION

Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

a) The Transnet e-Tender Submission Portal can be accessed as follows:

- Scroll towards the bottom right hand side of the page;
- On the blue window click on "register on our new eTender Portal";

- Click on "SIGN IN/REGISTER" - to sign in if already registered;

## 4 RFP INSTRUCTIONS

- 4.1 Please sign documents [sign, stamp and date the bottom of each page] before uploading them on the system. The person or persons signing the submission must be legally authorised by the respondent to do so.
- 4.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**
- 4.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 4.4 Any additional conditions must be embodied in an accompanying letter. Subject only to [Alterations made by the Respondent to Bid Prices] of the General Bid Conditions, (Legal Review) and Section 6 of the RFP, alterations, additions or deletions must not be made by the Respondent to the actual RFP documents.

## 5 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture [**JV**] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Transnet through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party.

In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to Transnet.

Respondents are to note that for the purpose of Evaluation:

- a JV will be evaluated based on one consolidated B-BBEE score card as per the B-BBEE Preferential Procurement Regulations, 2017 preference point scoring.
- Experience, qualification or certification of Lead Bidder (JV Partner with higher % split of Business) must have the required Experience, qualification or certification, where the split of business is 50/50, Experience, qualification or certification of either member of the JV will be used for evaluation.

## **6 COMMUNICATION**

- 6.1 Specific queries relating to this RFP before the closing date of the RFP should be submitted to the contact person specified in Section 1 of this RFP before **14h00 pm on 12 December 2022**. In the interest of fairness and transparency Transnet's response to such a query will then be made available to other bidders.
- 6.2 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFP between the closing date and the date of the award of the business.
- 6.3 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.
- 6.4 Respondents may also, at any time after the closing date of the RFP, communicate with the contact person specified in Section 1 of this RFP on any matter relating to its RFP response
- 6.5 Respondents are to note that changes to its submission will not be considered after the closing date.

## **7 CONFIDENTIALITY**

All information related to this RFP is to be treated with strict confidence. In this regard Respondents are required to certify that they have acquainted themselves with the Non-Disclosure Agreement. All information related to a subsequent contract, both during and after completion thereof, will be treated with strict confidence. Should the need however arise to divulge any information related to this RFP or the subsequent contract, written approval must be obtained from Transnet.

## **8 COMPLIANCE**

The successful Respondent [hereinafter referred to as the **Service Provider** shall be in full and complete compliance with any and all applicable laws and regulations.

## **9 EMPLOYMENT EQUITY ACT**

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

## **10 DISCLAIMERS**

Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- 10.1 modify the RFP's Goods/Services and request Respondents to re-bid on any such changes;
- 10.2 reject any Proposal which does not conform to instructions and specifications which are detailed herein;
- 10.3 disqualify Proposals submitted after the stated submission deadline [closing date];

- 10.4 award a contract in connection with this Proposal at any time after the RFP's closing date;
- 10.5 award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP;
- 10.6 split the award of the contract between more than one Supplier/Service provider, should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- 10.7 cancel the bid process;
- 10.8 validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;
- 10.9 request audited financial statements or other documentation for the purposes of a due diligence exercise;
- 10.10 not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provided for it;
- 10.11 to cancel the contract and/request that National Treasury place the Respondent on its Database of Restricted Suppliers for a period not exceeding 10 years, on the basis that a contract was awarded on the strength of incorrect information furnished by the Respondent or on any other basis recognised in law;
- 10.12 to award the business to the next ranked bidder, provided that he/she is still prepared to provide the required Goods/Services at the quoted price, should the preferred bidder fail to sign or commence with the contract within a reasonable period after being requested to do so. Under such circumstances, the validity of the bids of the next ranked bidder(s) will be deemed to remain valid, irrespective of whether the next ranked bidder(s) were issued with a Letter of Regret. Bidders may therefore be requested to advise whether they would still be prepared to provide the required Goods/Services at their quoted price, even after they have been issued with a Letter of Regret.

Note that Transnet will not reimburse any Respondent for any preparatory costs or other work performed in connection with its Proposal, whether or not the Respondent is awarded a contract.

## **11 LEGAL REVIEW**

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

## **12 SECURITY CLEARANCE**

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Goods/Services and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/ SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

## **13 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE**

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Respondents must register on the CSD prior to submitting their bids.

Business may not be awarded to a Respondent who has failed to register on the CSD.  
 Only foreign suppliers with no local registered entity need not register on the CSD.

***For this purpose, the attached SBD 1 form must be completed and submitted as a mandatory returnable document by the closing date and time of the bid.***

**14 TAX COMPLIANCE**

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.

Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

## SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

### 1 BACKGROUND

Transnet and its respective benefits funds requires administrative services. Transnet Benefit Funds do not fall under the Pension Funds Act (Act 24 of 1956) as amended, but fall under the Transport Pension Fund Act (Act 62 of 1990), as amended by the Transnet Pension Fund Amendment Act, 2000 (Act 41 of 2000).

The Rules of the Funds as amended from time to time must be adhered to. The Administrator will be required to provide assistance in the drafting of amendments and/or new Fund rules.

The Funds are subject to annual audits and statutory actuarial valuations and the Service Provider must provide all information that will be required, as requested.

Transnet currently has 55 000 employees.

Below table shows the estimated number of members per fund and these are variable on a monthly basis:

### 2 DETAILED SCOPE OF WORK

#### SPECIFIC SERVICES TO BE PROVIDED BY THE ADMINISTRATOR

Transnet seeks a competent Service Provider to provide a full-spectrum management of the benefit administration functionality associated with the TSDBF.

The Service Provider is required to manage litigation processes and with stakeholder queries and complaints, as and when required.

#### STAKEHOLDERS/ROLE PLAYERS:

The service provider is required to interact with the below stakeholders:

- Board of Trustees
- Principal Employer
- Sub-Committees appointed by the Board
- Principal Officer (The Principal Officer's office prepares the Board agenda packs with the assistance of the Administrator)

- Fund Valuator & Actuary
- Fund Auditor
- Fund Investment Consultant
- Asset Managers
- Risk Benefit Service Provider

## **MEETINGS:**

The following meetings are held on a regular basis:

- Trustee Board Meetings (quarterly).
- Executive Committee Meetings (monthly).
- Investment Committee Meetings (monthly).
- Risk and Compliance Committee Meetings (quarterly).
- Administration Sub-Committee

The Service Provider is required to ensure that appropriate data back-up and disaster recovery procedures are in place.

The following services to be provided by the Service Provider:

### **2.1 Members Management:**

2.1.1 The service provider is required to provide data management services, including:

- maintaining member and beneficiary personal details (local and foreign)
- maintaining member contributions

### **2.2 Benefit management processes**

2.2.1 The service provider is required to determine the Fund benefit payable and manage the end-to-end process in the case of:

- death,
- retirement,
- retrenchment,
- withdrawal
- dismissal.

### **2.3 Risk benefit management processes**

2.3.1 The service provider is required to determine the Fund benefit payable and manage the end-to-end process in the case of:

- Disability benefits,

- Death benefits,
- Death Investigation.

## 2.4 Pensioner Services

2.4.1 The service provider is required to provide data management services regarding pensioners, including

- Maintaining member and beneficiary personal details (local and foreign)
- Providing monthly interface with Department of Home Affairs
- Ensuring Certificate of Existence in place regularly
- Processing monthly annuity payments
- Processing and issuing annual tax certificates
- Processing spouse's pension
- Processing children's pension
- Providing benefit payment services, including:
  - Paying the amount due to pensioners (after deducting any taxes payable and medical aid contributions) as directed by the Funds.
  - Paying the required tax (to both SARS and over-border authorities, where applicable) and medical aid contributions.
  - Paying arrear pension instalments and deductions after re-instatement.
  - Paying of bonuses as declared by the Fund from time to time.
- Implementing pension increases and attend to any other payments that may be required in the course of operation of the Funds.
- Recover of over-payments through an existing process.
- Issuing monthly salary advice slips to pensioners.

## 2.5 Transnet Unfunded Benefit and Subsidy Payments:

2.5.1 Transnet has a number of unfunded benefit and subsidy payments it makes on a monthly basis to beneficiaries. There is some overlap between the pensioners receiving these payments and the pensioners of the Transnet Second Defined Benefit Pension Fund. To this end, Transnet is looking for a service provider to facilitate the payment of these pensions in conjunction with the administration of the Fund in order to achieve efficient maintenance of data and reduced combined costs.

2.5.2 The benefits and subsidies to be paid include:

- Transmed pensioners administration (medical subsidies paid by Transnet to Transmed). The approximate number of monthly payments is currently 10,000 – this is a closed group of payments.
- Workman's Compensation Act pensions and Retired Management Beneficiaries administration (benefits and top-up pensions paid by Transnet to qualifying employees). The approximate number of monthly payments is currently 735 – this is a closed group of payments.

- Providing cashflow management in terms of the agreed investment mandate.
- Providing actuarial valuation data to the Funds' valuator.

- Validating the Funds' investments as managed by external asset managers, taking instructions from the Trustees on the advice of the Investment Committee.

**2.9 Investment Accounting Services, including:**

- Providing daily unit price calculations
- Providing investment accounting and unitization
- Managing and liaising with Custodian, Asset Managers and the Fund
- Providing investment Cash Flow management
- Providing monitoring services in line with Regulation 28
- Reporting to the South African Reserve Bank

**2.10 Change Management, Communication and Training, including:**

- Member and trustee induction training
- Member pre-retirement training
- Providing member Guide
- Providing retirement Guide
- Providing Benefit and Projection statements
- Providing Retirement Benefit Counselling
- Compiling and publishing member newsletter
- Compiling and publishing of annual trustee report
- Scheduling and conducting roadshows, as and when required
- Providing special communication on instruction from the Board
- Conducting interviews with beneficiaries, as and when required
- Providing employer training
- Creating and maintaining member website and portal

- Coordinating the Annual General Meeting of the Fund

#### 2.11 **Employer Related Administrative Services:**

- Payments requested by TSDBF (Workmans Compensation, medical, tax and management)
  - Detailed reports supporting all the amounts on the invoices must be submitted for workmans compensation, Medical, Tax and Management portions together with invoices
  - Monthly invoices to be signed off by the Service Provider
  - A signed off reconciliation is required on a monthly basis, indicating payments requested, payments reversed (money recovered backed due to death) as well as payment received from Transnet before next invoice is submitted
  - Invoice must be submitted to Transnet in PDF format



5.6 **STEP FIVE: Post Tender Negotiations**

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
