1. PURPOSE

The purpose of this Request for Proposals (RFP) is to establish a panel of experienced Employment Verification Service Providers for 12 months for the KwaZulu-Natal (KZN) Growth Fund Trust.

2. BACKGROUND

KZN Growth Fund Trust (KGFT) is a fund, established and capitalised by the Provincial Government to provide debt and equity. The main objectives of the KGFT is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KGFT, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KGFT Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KGFT.

The KGFT wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

3. SCOPE OF SERVICES REQUIRED WORK AND DELIVERABLES

KZN Growth Fund Trust (KGFT) hereby requests experienced and reputable service providers to submit proposals in respect of Employment Verification.

3.1 SCOPE OF WORK

3.1.1 Employment Verification Service

Employment Verification Service agencies will be used for identity verification, criminal, credit and qualification checks which is one of the most important pre-employment requirements.

The verification agency will be required to:

- Verify the applicant's Identity;
- Verify the applicant's qualifications;
- To run criminal record and credit checks; and
- Any other appropriate verification that may be required by KGFT.

The service provider will be required to submit a report on the results.

4.1 Compliance with minimum requirements

All proposals must be accompanied by the following documents:

- 4.1.2 Evidence of registration on the National Treasury Central Supplier Database (or proof of registration);
- 4.1.3 Tax Compliance Status Certificate
- 4.1.4 Valid BEE Certificate **(Level 1, 2 and 3 will only be considered)**
- 4.1.5 Provide three written letters of reference for similar work performed. Letters must not be older than 3 (three) years
- 4.1.6 Employment Verification Service – Member of The National Association of Professional Background Screeners (NAPBS) or equivalent body

Failure to submit any of the above documents will disqualify the bidder from further evaluation

4.2. Price and B-BBEE Evaluation

4.2.1 Proposals will be subject to an evaluation based on an 80/20 price / BBBEE allocation - 80 points for price and 20 points for B-BBEE status of contribution.

4.2.2 Price must be inclusive of VAT and all costs relating to disbursements and accommodation. Pricing as per Annexure A.


