Compulsory site inspection for this Formal Quotation will be on Tuesday, 01 March 2022 at **10H00** am. The venue (meeting point) address for the site inspection is the **Oudtshoorn** Municipality Building in Voortrekker Road. Covid-19 regulations will be applicable and only one representative per company will be allowed to attend. Masks must be worn at all times and social distancing be adhered to. No more than 50 attendees will be allowed to be present at the meeting if more than 50 attendees intend to attend.

The municipality reserves the right to withdraw any invitation to tender and/or re-advertise or to reject any formal quotation or to accept a part of it. The Municipality does not bind itself to accept the lowest formal quotation or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this formal quotation may not materialize.

Formal quotations will be evaluated in terms of the 80/20 Preference Point System prescribed by the Preferential Procurement Policy Framework Act (Act 5 of 2017) and the Municipality's Supply Chain Management Policy. Further noting that the following is part of this quotation and therefore all prospective service providers that fail to attach proof will not be evaluated any further.

Valid CIDB Certificate indicating required Grading of 1ME OR HIGHER It is a prerequisite that all prospective service providers who are not yet registered on the Western Cape's Central Supplier Database register without delay on the website www.csd.gov.za.
