3.10verview

Onderstepoort Biological Products is ISO/9001:2015 certified and is a national key point. OBP is a State-Owned Company and must comply with provisions of the Public Finance Management Act, Treasury Regulations, as well as companies Act, no 71 of 2008 and King IV Report. Onderstepoort Biological Products is producing vaccines for animals with ±200 employees. Activities on the site include offices, laboratories, animal facility and stables, canteens, workshops, maintenance unit, clinic, and a boardroom centre. Activities offsite includes animal facilities/stables.

The objective of this bid is to appoint a suitable Supplier who will supply garments, washing and sterilization of protective clothing. The garments must be properly marked as per department, personnel and numbered (example 1 of 20), as a pair and packed according to specified departmental requirements. During the term of the contract the service provider will collect and deliver same day twice per week. Every delivery must submit supportive certificate e.g., certificate of sterilized garments.

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe* se prohibition meaning that it cannot be justified under any grounds.
