CONTRACT PERIOD

The contract will be for a period of **60 months (5) years**.

SPECIFICATIONS/SCOPE OF WORK

South African National Park seeks a service provider to run a 5-year for installation, supply and maintenance of dosing machines and laundry chemicals to addo elephant national park laundry for a period of sixty (60) months at Addo Elephant National Park. The focus areas of the service are:

- 1) Bidder should be able to install, supply and service dosing machines
- 2) Should supply liquid laundry chemicals as per pricing schedule (Liquid Detergent, Stain Remover, Fabric Softener, Alkali Booster)
- 3) Setting and monitoring dosing units on washing machines
- 4) On going maintenance to ensure continues service of the dosing machines for the duration of the contract including weekends and public holidays.

SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract.
