Clarification – Builders works in Connection to Fire Protection Installation

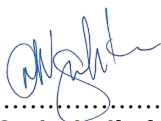
The tenderer is referred to Section 2, Page 254, item No. 5 for the Builders works in Connection to Fire Protection Installation trade in the tender Bill of Quantities.

Query: Could you kindly clarify - Section 2 Bill 20 if this is labour only for the doors and ironmongery, as they are measured somewhere else

Answer: The item for the door only applies to the fitting of the door frame only, not the actual door, the frame to be installed by the Contractor and not the carpenter that will be installing the doors.

The ironmongery items are for the supply and installation of ironmongery that will be installed with the frames instead of the doors for the compliance of fire rated doors.
