Tenders received will be evaluated in terms of the 80/20 Preferential Point System goals as prescribed in the amended Preferential Procurement Policy Framework Act (No 5 of 2000). The specific goals will be allocated as indicated in the table below:

Category of persons	100% Youth owned = 5 points, more than or equal to 51% Youth owned = 3 points, less than 51% Youth in shareholding = 1 point Maximum of 5 points
Gender	100% Women owned = 5 points, more than or equal to 51% Women owned = 3 points, less than 51 % Women owned = 1 point Maximum points of 5 points
Race	100% Black owned = 5 points, more than or equal to 51% Black owned = 3 points, less than 51% Black owned = 1 point, Maximum points of 5 points
Disability	100% people with Disability owned = 5 points, more or equal to than 51% people with Disability owned = 3 points, less than 51% people with Disability owned = 1 point Maximum points of 5 points
