1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to appoint a qualified, appropriately certified service provider to conduct a TOTAL REWARD audit to give assurance that the TOTAL REWARD resulted in accurate remuneration of SANParks employees.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks makes use of the SAGE300 system to manage its TOTAL REWARD for +- 5500 employees on a monthly basis.

3. SCOPE OF WORK

SANParks requires the services of an independent, competent and appropriately certified service provider to conduct a TOTAL REWARD audit to give assurance that the TOTAL REWARD resulted in accurate remuneration of employees, Board and Independent Contractors and that correct taxes were appropriately withheld in terms of the South African-Reward Associates (SARA).

The service provider must provide the below services:

Data Validation and Integrity Testing

The service provider must:

- Validate employee-level data used in the implementation, including:

Job titles

- o JE outcomes
- o Current salaries
- o Allowances and guaranteed pay elements
- Reconcile HRIS, JE, and TOTAL REWARD data for consistency.
- Identify missing, incorrect, or misaligned data.

Pay Structure and Range Architecture Review

The service provider must:

- Identify inconsistent or inequitable placements.

Employee placement diagnostic and compa-ratio analysis.

Pay Equity and Equal Pay Analysis

The service provider must:

- Conduct statistical diagnostics to assess equal pay for work of equal value.
- Analyse pay outcomes by:

- Identify unexplained pay differentials.
- Assess compliance with applicable labour and equality legislation.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

- Ps = Points scored for price of tender under consideration
 Pt = Price of tender under consideration
 Pmin = Price of lowest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,then the organ of state must indicate the points allocated for specific goals for 80/20 preference point system.
